Subject: Operator Apprenticeship Grant Amendment #3

Proposed Action

That the Metropolitan Council authorize the Regional Administrator to execute grant amendment 3 for contract 2019-222/METRO2018MAI with the State of Minnesota.

Summary of Committee Discussion/Questions

Metro Transit Deputy Chief Operating Officer- Bus Brian Funk presented this item. Zeran asked who decides if the apprentices completed the program and if there was a third party review. Funk responded that Metro Transit is keeping track of milestone achievements (ride alongs, group meetings, etc.) and when all milestones are completed and the first year of employment is complete, Metro Transit notifies the state. Funk continued that there is an established Joint Apprenticeship Committee (JAC) which includes Metro Transit Management and ATU President and Vice President who meet regularly regarding the program. Zeran asked if Funk could speak to Traction Power's apprenticeship, to which Chair Barber stated she could get Zeran in contact with the correct staff. Zeran ask if the training modules and steps for program completion are clear to the apprentices. Funk stated to his knowledge the program requirements are clear and he hasn't heard otherwise. Fredson thanked Funk and staff for assisting with this program as it is a great program and making a huge difference in connecting people to full time employment.

Proposed Action

That the Metropolitan Council authorize the Regional Administrator to execute grant amendment 3 for contract 2019-222/METRO2018MAI with the State of Minnesota.

Background

Metro Transit is the recipient of grant funding (Minnesota Apprenticeship Initiative) from the State of Minnesota for the Bus Operator Apprenticeship Program. The Bus Operator Apprenticeship program is a second in the nation program to mentor new bus operators during their critical first year on the job. More than 200 newly hired bus operators have entered the apprenticeship since the program started in September 2018. The original grant authorized up to \$500,000 for reimbursable expenses. A 2019 Amendment authorized an additional \$500,000. At this time, the grant has paid approximately \$1,000,000 to Metro Transit for eligible expenses, primarily training. This amendment will allow for additional grant funds, up to \$265,000 to be collected by Metro Transit.

Rationale

This amendment will allow for additional grant funds, up to \$265,000 to be collected by Metro Transit for reimbursable expenses.

Thrive Lens Analysis

- Stewardship: This grant agreement provides valuable financial resources to continue the Apprenticeship program.
- Prosperity: The Apprenticeship program, funded largely by this grant, contributes to the development of a talented workforce who contribute to the regional economy.
- Equity: The grant funding ensures that all new bus operators have access to the benefits of an apprenticeship model with valuable mentor relationships from the start of their careers.
- Livability: This program and grant investment will contribute to the retention of a skilled workforce who will benefit from an improved quality of life.
- Sustainability: Workforce development programs such as this Apprenticeship will ensure that Metro Transit has the appropriate number of skilled staff to deliver our sustainable transit services to the region.

Funding

This amendment will allow Metro Transit to receive additional grant funds up to \$265,000.

- (a) **Compensation.** The GRANTEE will be reimbursed according to the budget summary provided in Exhibit 2(a) which replaces Exhibit 2, Exhibit 2(b), which is attached and incorporated into this grant contract to support activities within the Work Plan.
- (b) **Total Obligation.** The total obligation of the State for all compensation and reimbursements to the GRANTEE under this grant contract will not exceed **\$1,000,000.00**, **\$1,265,000.00**.
