Proposed Action

That the Metropolitan Council authorizes additional expenditure within agreement 171009 with the Minnesota Department of Transportation not to exceed \$7,574,848, for a revised total authorization not to exceed \$54,446,598.

Background

On March 22, 2017 through business item 2017-65, the Metropolitan Council authorized the Regional Administrator to negotiate and execute agreement 17I009 with MnDOT in an amount not to exceed \$46,871,750. This agreement enables the construction of Orange Line transit improvements along I-35W by MnDOT within a larger \$239 million roadway reconstruction project led by MnDOT.

The 2017 agreement authorization value was based on the estimated local share of construction, with an estimated additional \$3.27 million of project delivery costs anticipated for future Council approval following federal funding award. The project's full funding grant was awarded in June 2019.

Based on actual bids received by MnDOT in August 2017, transit-related construction to be paid by Council to MnDOT total \$51,520,569.59, an increase of \$1,380,569.59. An additional \$7 million of federal CMAQ funds awarded through the 2017 Regional Solicitation within will be drawn directly by MnDOT for transit station construction.

Finally, additional Council authorization is requested for potential change orders within the MnDOT project. Change orders to date total \$526,064, around 1 percent of the construction cost. Authorization is requested up to 5 percent of the bid costs, or \$2,926,028.43. Payment will be limited to the actual cost of change orders for transit-related work.

In combination, increased authorization of \$7,574,848 is requested through this action in agreement 171009, for a revised total payment value not to exceed \$54,446,598.

Rationale

Council policy requires interagency agreements above \$500,000 to be approved by the Council. The ongoing partnership with MnDOT is progressing on time and within budget, and authorization of the actual construction costs will enable continued work toward completion in 2021.



Thrive Lens Analysis

METRO Orange Line supports Thrive outcomes including livability, prosperity, and equity by providing new access to economic and personal opportunity through the I-35W south corridor. The proposed action advances the prosperity outcome by advancing an infrastructure project that will create regional economic competitiveness, and equity outcomes by better connecting the region's residents to enhanced, accessible transit service.

Funding

Funding is available within the Council's Authorized Capital Program in project #62405. Funding sources include federal Small Starts, state bonds awarded for Orange Line construction, and county funding grants.


Downtown Minneapolis to Burnsville

- Construction 2017-2021, aligned with major highway projects on I-35W






MnDOT Cooperative Construction Agreement 171009

Authorized by Council in March 2017 by business item 2017-65

Authorizes Orange Line construction within a \$239 million I-35W reconstruction led by MnDOT

- New 12th Street transit-only access ramp to/from downtown Minneapolis
- Transit-related roadway and bridge costs
- New I-35W & Lake Street Station
- MnDOT services for project delivery

In 2017, Council authorized \$46.871 million of local share expenditure following preaward approvals from counties and FTA, planned future authorization of full cost.

Proposed Action

- Reflects progress since Q1 2017
 - Aligns authorization to actual bid costs received and awarded by MnDOT in 2017
 - Reflects FHWA/FTA coordination of federal highway funds allocated for station construction (CMAQ)
 - Authorizes full agreement cost expenditure, following federal full funding award in June 2019
- Authorizes change order authority for project changes, not to exceed 5 percent of costs
- Full funding available in Project 62405, funded by state, county, and federal sources
