Proposed Action

That the Metropolitan Council authorizes purchase of Odor Control Media Items 1, 2, 3, 6, 9, and 10 from Purafil, Inc., in the amount of \$832,940.00 and Odor Control Media Items 4, 5, 7, and 8 from Total Mechanical Services, Inc., in the amount of \$732,000.00, 2020 Odor Control Media Procurement, contract 19P361.

Background

MCES owns and operates over thirty odor control units throughout the region that mitigate odors associated with the regional wastewater system. These units require periodic replacement of various types of media. The work is performed by MCES staff.

The Invitation for bids (IFB) with ten-line items to be bid individually by line was advertised on January 15, 2020. There were ten plan holders. Procurement facilitated a public bid opening on February 18, 2020. Two bids were received on all ten-line items. The Office of Equal Opportunity (OEO) did not set a goal.

Purafil, Inc., was the lowest, responsive, and responsible bidder for Carbon Media items 1, 2, 3, 6, 9, and 10. Total Mechanical Services, Inc., was the lowest, responsive, and responsible bidder for Carbon Media Items 4, 5, 7, & 8.

Rationale

The award and execution of contract for goods in excess of \$500,000 requires Council approval.
