### **Proposed Action**

That the Metropolitan Council authorizes the Regional Administrator to execute a grant agreement with Minnesota Valley Transit Authority for operating assistance on the Orange Line Connector expansion bus route. in the amount of \$1,920,000.

### **Background**

The Transportation Advisory Board awarded a Congestion Mitigation Air Quality Program (49 U.S.C. 5307) grant to Minnesota Valley Transit Authority through the 2018 regional solicitation on February 20, 2019 for expansion of bus service. Funding is provided for service costs at an 80-percent federal share and 20-percent local share, which Minnesota Valley Transit Authority is responsible for providing.

#### Rationale

The requested action will allow the Regional Administrator to execute a grant agreement with Minnesota Valley Transit Authority to allow them to implement new service for their Orange Line Connector bus route. The Metropolitan Council may award grant funds to meet specific public purpose needs. Council action is required for the Regional Administrator to execute agreements over \$500,000.
