### Proposed Action

That the Metropolitan Council authorizes the Regional Administrator to negotiate and execute a Joint Powers Agreement number 211030 on behalf of the Metro Transit Police Department with the State of Minnesota's Department of Public Safety – Bureau of Criminal Apprehension (BCA). MTPD is also requesting that the Regional Administrator negotiate and executive an amendment to this JPA for Court Data Services.

### Background

The BCA is the administrative entity for all criminal justice information for law enforcement agencies across the state. This is authorized under Minn. Stat. § 299C.46. This JPA is before the Council as a renewal only.

### Rationale

A Joint Powers Agreement with the BCA is necessary to performing the basic functions of the department because the BCA is the holder of criminal justice data/information. Without access to this information, officers would be unable to query state and federal criminal justice data.
