Background

On November 18, 2020, the Council approved Business Item 2020-292 authorizing the Regional Administrator to submit grant applications to the Funding Transitway Counties for 2021 funding. All submitted grant applications were reviewed and approved by the Funding Transitway Counties. This proposed action will allow agreements to be executed with the Funding Transitway Counties to accept the grant awards.

All county operating grants are subject to standard conditions including narrative and financial reports.

Rationale

County operating grant funds will provide up to 50% of the net cost of transitway operations for the calendar year 2021.
