Summary of Committee Discussion/Questions

Jessica Lee, Senior Parks Planner, presented the staff report to the Community Development Committee at its meeting on July 6, 2021. Several Council Members expressed their support for the funding recommendations and that they look forward to future evaluation of the program's success. There were no questions and the Community Development Committee voted unanimously, with one abstention, to approve the proposed actions.

Summary of Commission Discussion/Questions

Jessica Lee, Senior Parks Planner, presented the staff report to the Metropolitan Parks and Open Space Commission at its meeting on July 1, 2021. Commissioner Assata Brown asked who served on the review team for the application review process. Ms. Lee responded that members of the Metropolitan Parks and Open Space Commission, the Community Development Committee, the Equity Advisory Committee, and a couple Implementing Agency staff served on the review team.

Commissioner Jeremy Peichel provided feedback around the takeaways from the review team. He emphasized that the review team saw a lot of growth in community and partner engagement from the last application round, especially around engaging with the partners in advance of submitting the applications. He said projects that scored the highest were developed beginning with equity in mind. He also referred to the proposals to hire BIPOC staff with the grant funding and commented that there needs to be a transition plan to hire BIPOC staff permanently after the grant funding ends. This requires an overall goal and commitment of the agencies to diversify staff. Also, Commissioner Peichel commented that he would like to see more emphasis on transit options for residents to access parks and trails beyond the urban core.

Commissioner Bob Moeller was happy to see that some of the funded projects seek to increase awareness of the regional system. He recommends the Council pursue this goal on a system level.

Lastly, Commissioner Brown made a recommendation that in future funding rounds staff should include a short synopsis for each project so that Commissioners not on the review committee are able to better understand the project purposes. It is difficult to know how to vote without this information.

The Metropolitan Parks and Open Space Commission voted 5-1 to recommend the proposed action.

Proposed Action

That the Metropolitan Council:

- 1. Approve funding 23 projects totaling \$2,054,000 for the Regional Parks System 2021 Equity Grant Program, as shown in Table 1 of this report.
- 2. Authorize the Community Development Director to execute the grant agreements on behalf of the Council.

Background

The 2040 Regional Parks Policy Plan commits the Council to develop a set-aside, competitive equity grant program to strengthen equitable use of the Regional Parks System. The Regional Parks System Competitive Equity Grant Program (Equity Grant Program) was formally established in 2019 through a pilot program with capital funding that resulted in awards for three Regional Park System equity projects. The pilot program, with feedback from the regional park implementing agencies and 2019 review committee members, illustrated the need for non-capital funding to support equity programming projects. The Council responded by authorizing \$1.4 million in Parks Interest Earnings for the Equity Grant Program. These dollars may be used to fund operating costs, including programming and staff.

The Council adopted the 2021 Regional Park System Competitive Equity Grant Program Notice of Funding Availability (*Business Item 2021-2*) after receiving input from the Metropolitan Parks and Open Space Commission, the Community Development Committee, the Equity Advisory Committee, and regional park implementing agencies' directors, planners, and outreach staff. The 2021 Equity Grant Program emphasizes partnership building, equity programming efforts, internal and inter-agency collaboration, and designing accessible capital projects that not only meet Americans with Disabilities Act (ADA) requirements, but provide innovative ways to bring meaningful, rich experiences to users.

Review Process

The ten Regional Parks Implementing Agencies submitted 37 applications requesting a total of \$3.8 million. The applications were reviewed internally for eligibility and completeness and then provided to a formal review committee, comprised of members of the Metropolitan Parks and Open Space Commission, the Council's Community Development Committee, the Council's Equity Advisory Committee, and representatives from the Regional Parks Implementing Agencies. This review committee evaluated and scored the projects and then met on May 14, 2021, to develop the funding recommendations shown below in



Table 1. Of the 37 applications submitted, 23 are recommended for funding, using \$2,054,000 of the available \$2,064,000. All ten agencies are recommended to receive at least one grant.

While agencies were able to apply for multiple projects, there are several limitations to awards, including:

- An agency may not receive more than \$200,000 of available capital funds.
- An agency may not receive more than \$200,000 of available interest earnings funds.
- No individual grant may exceed \$200,000.

Some projects that scored high as shown in Table 2 below are not recommended for funding simply because the Agency has reached their award limit with higher ranked projects. The review team also considered previously funded projects, the geographical distribution of all projects, and made funding recommendations based on the potential equity impact throughout the region.

Rationale

The 2040 Regional Parks Policy Plan, Finance Chapter 8, Strategy 4 states that equity is a consideration in the Regional Parks System funding and investment. The Regional Parks Equity Grant Program is one Council strategy for advancing equity in the region.

Thrive Lens Analysis

The competitive equity grant program seeks to advance the *Thrive MSP 2040* outcome of equity by increasing the equitable usage of the Regional Parks System by all residents of the region.

Funding

Up to \$2,064,000 is available in the authorized budget for the 2021 Equity Grant Program. This includes \$664,000 in Parks bonds and \$1.4M in Parks Interest Earnings.
