Proposed Action

That the Metropolitan Council authorize the Regional Administrator to execute grant agreements funded by Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA) with the following transit agencies:

Background

The Federal Transit Administration (FTA) allocated approximately \$185 million in CRRSAA funds to the Metropolitan Council. The Council allocated funds to all regional transit providers using established allocation formulas. Just under \$10 million will be passed through via grant agreements and the Council will retain the balance. Funding is provided at a 100-percent federal share, with no local match required, and will be used to support expenses eligible under the Section 5307 program. The Act directs recipients to prioritize payroll and operational needs.

Rationale

The requested action will allow the Regional Administrator to execute grant agreements with regional transit providers so they may continue operations during the Covid-19 pandemic. The Metropolitan Council may award grant funds to meet specific public purpose needs. Council action is required for the Regional Administrator to execute agreements over \$500,000.

Thrive Lens Analysis

These projects promote stewardship, equity, sustainability, and livability by furthering access to transit.

Funding

Federal funding for these grants is available. This item is contingent upon adoption of BI 2021-143, 2nd Quarter Budget Amendment, that will be presented at the July 26, Transportation Committee Meeting and the August 11 Council Meeting.
