Subject: Occupational Health, Medical, Drug, Alcohol Collections, Lab & TPA Services, Contract 21P068

#### **Proposed Action**

That the Metropolitan Council authorize the Regional Administrator to negotiate and execute contracts 21P068(A-D) with Minnesota Occupational Health, Inc. to provide occupational health medical services, drug and alcohol collection and lab services in an amount not to exceed \$3,962,650, and with CMS Medical Services to provide drug and alcohol program administration services in an amount not to exceed \$248,133. The total procurement value will not exceed \$4,210,693.

### **Summary of Committee Discussion/Questions**

The Chair requested information about the length of the contract and whether the pricing of the contract was similar to prior contracts. The contract duration is 5 -years. Pricing is similar to prior contracts.

The Chair inquired about the number of MCUB proposers and the processed used to notify MCUB vendors about the solicitation. Representatives from Procurement and the Office of Equal Opportunity discussed efforts taken to identify and notify MCUB vendors about the solicitation.

The Committee discussed outreach efforts to notify and engage MCUB vendors for future solicitations.

#### **Proposed Action**

That the Metropolitan Council authorize the Regional Administrator to amend contract 17P110 with Minnesota Occupational Health (OCC), for an additional \$200,000. The new contract total will be \$1,164,000. OCC will continue to provide occupational health & medical services to Council employees through October 31, 2020.

### **Background**

The contract and funding are required to provide medical services to meet the business and regulatory needs of the Council. These services include pre-employment, DOT, and Fit for Duty medical exams, Rail vision exams, audiograms, respirator fit-testing, and exposure prevention services for employees in safety-sensitive positions.

#### Rationale

Council Policy 3-4-3(a) establishes expenditure procedures relative to procurement actions. Section 2.1.2.23 states, "Amendments that are greater than 10% of the original contract value. If the amount is greater than \$500,000 and the Council has already acted upon the item because of its value, then additional amendments, if they exceed the 10% threshold, regardless of amount, must be approved by the Council".

## **Thrive Lens Analysis**

Authorization to enter into a contract with Minnesota Occupational Health for medical services supports the Thrive outcome of Stewardship by providing occupational medicine services that prevent and treat job-related injuries and illnesses as well as assist with assuring services to the public are provided by employees who are safe and healthy to do so.
