Proposed Action

That the Metropolitan Council adopt an amendment to the 2022-2025 Transportation Improvements Program (TIP) to add a new MnDOT-sponsored project replacing the wearing course on US 61 Bridge # 19004 over Mississippi River in Hastings.

Background

This request is to add a new project on US 61 Bridge #19004 over the Mississippi River in Hastings, replacing the wearing course. This project is to be funded with National Highway Performance Program (NHPP) funds. The \$3.2 million in federal funds is available from a US 10 Reconstruction project, which released \$10.7 million.

Rationale

The Metropolitan Council approves formal amendments to the TIP. The projects are consistent with the Transportation Policy Plan (TPP) and meet fiscal constraint because the federal, state, and local funds are sufficient to fully fund the projects. The Minnesota Interagency Air Quality and Transportation Planning Committee determined that the project is exempt from air quality conformity analysis.

Thrive Lens Analysis

This action promotes *stewardship* by adding a protective layer to a bridge that will preserve rebar and delay more significant repairs.

Funding

The project is fully funded with federal and local funds.

Small Business Inclusion

This project includes federal funding. Therefore, Disadvantaged Business Enterprise (DBE) requirements will apply.

Known Support / Opposition

This proposed action was reviewed and recommended by the Transportation Advisory Board. No known opposition.
