Proposed Action

That the Metropolitan Council passes Resolution 2022-9 authorizing the acquisition of temporary easements for the L48 Rehabilitation and Forcemain 6-DH-645 Replacement project and staff to initiate condemnation proceedings.

Background

Lift station 48 and Forcemain 6-DH-645 are reaching the end of their service life. The 10-inch forcemain will be replaced via directional drilling. Approximately 1,000 feet of gravity pipe will be replaced via open cut construction. Temporary easement rights are necessary to accommodate temporary conveyance piping, construction staging and access.

Rationale

The acquisitions are necessary to implement the proposed interceptor improvements. This action delegates authority to staff to acquire the necessary property rights for the project and to use the condemnation process, if necessary, to ensure timely project delivery.

Thrive Lens Analysis

This action advances the Thrive Outcome of Stewardship. Public financial resources will be invested efficiently and effectively to maintain and restore existing wastewater infrastructure, which protects the region's natural resources and public health.

Funding

Project 802834 is included in the 8028 family of projects in the 2022 MCES Authorized Capital Program. Public Facility Authority funds will be used for the project.

RESOLUTION NO. 2022-9

RESOLUTION AUTHORIZING THE ACQUISITION AND CONDEMNATION OF REAL PROPERTY NECESSARY FOR METROPOLITAN COUNCIL PROJECT NO. 802834.

WHEREAS, Metropolitan Council Project No. 802834 (the "Project") requires the acquisition of real property.

NOW THEREFORE BE IT RESOLVED:

The Metropolitan Council finds and declares:

- (1) that the Project is a valid public project with a valid public purpose;
- (2) that the real property needed for the Project will be more particularly identified in the Project Plans or on the Project Work Map (the "Property");
- (3) that the Property is necessary for the Project and must be obtained before the filing of an award by the court-appointed commissioners;
- (4) that, in the judgment of the Metropolitan Council, the acquisition of the Property will further the public health, safety and welfare, and will be undertaken in accordance with Minnesota Statutes and the Real Property Acquisition Policy of the Metropolitan Council;
- (5) that, under Minnesota Statutes Section 473.504, the Metropolitan Council has the authority to acquire the Property by condemnation, and that the Council directs its attorneys to acquire the Property by condemnation if the Property cannot be acquired by direct negotiation; and
- (6) that the condemnation of the Property will be done in accordance with the procedures authorized under Minnesota Statutes Chapters 473 and 117.
