Rapid PCR On-Site Covid Test Kits, Contract 21P385

Proposed Action

That the Metropolitan Council authorize the Regional Administrator to award and execute contract 21P385 with Cue Health Inc., for Rapid PCR On-Site Covid Test Kits in the amount not to exceed \$2,508,400 for one year with an option to extend an additional year.

Summary of Management Committee Discussion/Questions

Successful pilot programs on PCR Rapid Testing have been conducted at both Metro Mobility and the Metro Transit Police Department. There is no minimum purchase required as part of this proposed contract. Approval of the contract with Cue Health Inc will allow the Council to implement future testing programs, in the event they are needed in the future, with speed and efficiency. The Invitation for Bids was advertised on January 21, 2022. A pre-bid meeting was hosted by Council staff that outlined the solicitation requirements, discussed project specifications and responded to plan holder inquires. There were thirty-one plan holders, thirty prime bidders, one plan room, and fourteen plan holders identified as woman, minority, veteran or disadvantaged business enterprises. Procurement facilitated a public bid opening on February 9, 2022, and five bids were received.

The five bids received ranged from \$2,000,000 to \$6,050,000. Cue Health Inc. is the lowest, responsive, and responsible bidder at \$2,508,400 and recommended for award. The award and execution of a goods contract in excess of \$500,000 requires Council approval. Funding for this item is included in the Departments' operating budgets.
