Metropolitan Council Meeting – January 25, 2023



2023 Session



First year in the biennium

- Session convened on Tuesday, January 3, 2023
- This session, the legislature and administration will be considering the historic state surplus and setting a twoyear budget for the state

November 2022 budget forecast

Forecast shows a budget surplus for the state

- Projected general fund balance in FY 2024-25 now \$17.6B, of which ~\$12B is leftover from previous biennium.
 - Lower expected income growth reduces tax revenue forecast.
 - Lower health care costs reduce spending forecast.
 - Inflation is not included in budget projections.
- Revenues expected to exceed spending through FY27
 - Forecast includes mild U.S. recession next year and slower economic growth through 2027.
- November 2022 forecast showed a lower MVST forecast than the February 2022 forecast
- Forecast will be updated February 2023

Regional parks and trails system



Proposed budget items

- Modernizing regional parks and trails
 - \$12 million in one-time spending matched with \$2 of Metropolitan Council funds for every \$3 from the state – supporting improvements for the Metropolitan Regional Parks System
- Regional parks operations and maintenance
 - \$12.49 million each year (\$24.99 million for the biennium) for parks operations and maintenance; distributed to the 10 implementing agencies
 - Combination of Lottery-in-lieu and General Fund
- Legacy Parks and Trails Fund
 - Continues 40/40/20 split for Regional Parks, State Parks (DNR), and Greater Minnesota Parks & Trails
 - \$26.823 million in FY2024 and \$25.241 million in FY2025 for regional parks; projects selected by the elected boards of the implementing agencies

Environmental Services



Proposed budget items

- Mapping Infrastructure Climate Risk and Resiliency Opportunities
 - \$5 million in one-time general fund spending to develop a climate impact assessment tool and refine and generate new data that will feed into it.
- Clean Water Fund recommendations:
 - Water Sustainability Support: \$1.125 million in each year for FY24 and FY25 to support the Council's Water Supply Sustainability Program
 - Water Efficiency Grants: \$750,000 in each year for FY24 and FY25 for the Council's region-wide initiative to give grants to local governments to offer rebates or grants to residents to upgrade to more efficient appliances

Transportation

Proposed Budget items

Sustainable, reliable transit funding

- Expanding transit investment with an 1/8 cent sales tax in the metropolitan area, starting October 1, 2023
- Funds the regional bus and transitway system
- Addresses the fiscal cliff

Regional Transit Capital Bonds

- Authorized total for FY 2024 and FY 2025 would be \$104.545 million
- Used for replacement buses, bus facilities, and other capital enhancements.
- Includes Metro Transit, Metro Mobility, Opt-Out Providers, and Dial-a-Ride Programs

Acceleration Zero Emissions Public Transit Bus Transition

- \$29.2 million in one-time funds would purchase up to 30 battery electric buses with charging infrastructure in place of diesel buses
- Could tap into competitive federal funds from the IIJA
- Allows us to exceed our goal of having at least 20% of bus replacements be zero emission buses by 2027







Transportation Policy Proposal

Transit safety and administrative citations


- Safety and security
 - Top priority for the Met Council
 - Proposal would have transit safety officials check fares
 - Allows police officers to spend their time addressing more serious incidents instead of performing routine fare inspection

Administrative citations

- Alternative to judicial citation a misdemeanor with a \$180 fine and adjudicated by the courts
- Council would develop program to process citations

- The legislature must adjourn by May 22, 2023
