# **Proposed Action**

That the Metropolitan Council adopt an amendment to the 2023-2026 Transportation Improvement Program (TIP) to amend the scope and increase the cost of one project and increase the cost of another.

## **Background**

The following project amendments are proposed for amendment in the 2023- 2026 TIP:

- 1. MnDOT requests a cost increase to its Stone Arch Bridge repair project. This change will also be reflected in the 2024-2027 TIP. This project is funded by Surface Transportation Block Grant Program (STBGP) funds. (Pages 2-3).
- 2. MnDOT requests a cost increase and the replacement of an additional bridge to its MN 65 bridge replacement project in Spring Lake Park and East Bethel. This project is funded by National Highway Performance Program (NHPP) funds. (Pages 4-5).

## **Rationale**

The Metropolitan Council approves formal amendments to the TIP. The projects are consistent with the Transportation Policy Plan (TPP) and meet fiscal constraint because the federal, state, and local funds are sufficient to fully fund the projects.

#### PROJECT BACKGROUND:

1. Briefly describe why amendment is needed (e.g., project in previous TIP but not completed; illustrative project and funds now available; discretionary funds received; inadvertently not included in TIP).

This amendment is needed to increase the total project cost from \$12,200,000 to \$25,238,000. The scope remains the same. This will also be reflected in the final 2024-2027 TIP.



This amendment is needed for a scope change to include an additional bridge and cost increase.

The total project cost increases from 33,124,770 to 38,015,000 an increase of \$4,890,230 (4,000,352 NHPP/BFP federal funds). Because this is a 2024 project, it will be included in the Met Council 2024-2027 TIP and Metro District will program the project in the 2024-2027 final STIP and will align its program to meet MnDOT 2024-2027 STIP funding guidance. Therefore, fiscal constraint is maintained.
