# **Background**

Per Council bylaws, the Council Chair shall recommend to the Council for approval at its first regular meeting in February, or as soon thereafter as possible, the Chair, members, and responsibilities of each standing committee. This action was taken on March 8, 2023. Due the 2023 redistricting process, reappointments to Council committees are needed following the appointment of Council Members by Governor Tim Walz on June 27, 2023. The Council Chair may also recommend to the Council for its approval, the Chair, members, and duties of special committees.
