Fuel Supply for Metro Mobility, Contract 23P125

Proposed Action

That the Metropolitan Council authorize the Regional Administrator to award and execute contract 23P125 with Sunoco, LLC, to supply and deliver gasoline to contract operators of Metro Mobility transit services in an amount not to exceed \$33,179,794.

Summary of Transportation Committee Discussion/Questions

Metropolitan Transportation Services Metro Mobility Operations Manager Clay Stenback presented this item. Vento asked if the mini vans would reduce fuel cost. Metropolitan Transportation Services Executive Director Charles Carlson stated that is something that will be monitored and that'd we'd expect the fuel consumption to be lower with smaller vehicles, but the vehicles might end up driving more miles overall. Cameron asked what the length of the contract was. Stenback stated this is a three-year contract and we'd put the contract out for bid again in about two and a half years.

Proposed Action

That the Metropolitan Council authorize the Regional Administrator to award and execute contract 23P125 with Sunoco, LLC, to supply and deliver gasoline to contract operators of Metro Mobility transit services in an amount not to exceed \$33,179,794.

Background

Metro Mobility has 665 gasoline powered vehicles in service. The fuel to operate these vehicles is purchased by the Council through a contracted supplier and delivered to the provider-owned fueling stations. The price is based on estimated delivery of 3.8 million gallons annually to Metro Mobility's contractors; Transit Team and First Transit as well as our new Waiver program.

The Invitation for Bids was advertised on August 23, 2023. A pre-bid meeting was hosted by Council staff that outlined the solicitation requirements, discussed project specifications and responded to plan holder inquiries. There were nine (9) plan holders, seven (7) prime/suppliers and two (2) plan rooms. No plan holders were identified as woman, minority, small, veteran or disadvantaged business enterprises.

Procurement facilitated a public bid opening on September 27, 2023 and four (4) bids were received. Bids ranged from \$33,179,794.00 to \$34,324,688.03. Sunoco LLC is the low, responsive, and responsible bidder and recommended for award. Actual expenditures will be determined by the Oil Price Information Service price index for gasoline, which will fluctuate daily over the three-year contract term to reflect petroleum market prices.

Rationale

The execution of a goods and services contract exceeding \$500,000 requires Council approval.
