Proposed Action

That the Metropolitan Council authorize the Regional Administrator to award and execute contract 23P078 with ROM, Inc. to provide cleaning services for sumps, sand traps, trench and plumbing drains that will support Metro Transit Engineering and Facilities in an amount not to exceed \$563,256.

Background

The Engineering and Facilities 2023 – 2028 maintenance budget will request future budget authority for funding associated with the routine maintenance of Council assets, **including** plumbing and drain systems to remove excess water and fluids from Transit operated facilities. Properly functioning drain systems are essential for building maintenance related to work to maintain a State of Good Repair required by the FTA.

An Invitation for Bids was issued on July 5, 2023. A pre-bid meeting was hosted by Council staff that outlined the solicitation requirements, discussed project specifications, and responded to plan holder inquiries. There were sixteen plan holders, ten prime bidders, three subcontractors, three plan rooms, and seven of the plan holders identified as minority, woman, small, veteran, or disadvantaged business enterprises.

Council staff facilitated a public bid opening on August 8, 2023, and three bids were received. Bids ranged from \$563,256 to \$3,308,765, and ROM, Inc. was the low, responsive, responsible bidder and recommended for award.

Rationale

The execution of a non-construction services contract that exceeds \$500,000 requires Council approval.

Thrive Lens Analysis

This action promotes Stewardship through needed rehabilitation and maintenance of existing Metro Transit assets.

Funding

The Engineering and Facilities 2023 – 2028 maintenance budget will request future budget authority for funding associated with contract 23P078.

Small Business Inclusion

The Office of Equity and Equal Opportunity (OEEO) assigned a Metropolitan Council Underutilized Business (MCUB) goal of 6% for this project. OEEO has determined that the recommended bidder has met the Council's MCUB contract requirements for this project.
