Amendment of Declaration of Emergency Repair of Interceptor 1-MH-401B Lilydale Siphon

#### **Proposed Action**

That the Metropolitan Council amend Emergency Declaration 2023-178 for repairs to Interceptor 1-MH-401B Lilydale Siphon in Saint Paul in the amount not to exceed \$3,000,000.

#### **Summary of Environment Committee Discussion/Questions**

- CM Wulff asked: Does the extra two million dollars affect our budget or is it within what we have to work with?
- Staff responded: We've reviewed our budget from last year, this can be accomplished within the current ACP budget.
- CM Lindstrom asked: Is this cured in place product?
- Staff responded: It is not a cured in place product. The water pressure inflates it into a round shape. The water pressure in the pipe and the existing siphon pipe will prevent any soil from collapsing.

Amendment of Declaration of Emergency Repair of Interceptor 1-MH-401B Lilydale Siphon

#### **Proposed Action**

That the Metropolitan Council amend Emergency Declaration 2023-178 for repairs to Interceptor 1-MH-401B Lilydale Siphon in Saint Paul in the amount not to exceed \$3,000,000.

#### **Background**

In the afternoon of July 17, 2023, a wastewater leak was reported along the 1-MH-401 siphon in the City of Saint Paul in the area southeast of Shepard Road and Interstate 35E and north of the Mississippi River. Emergency cleanup activities commenced immediately, stopping the leak and collected spilled wastewater on the ground surface for disposal. Cleanup work was completed July 23. Emergency Declaration 2023-178 was ratified by the Metropolitan Council on August 23.

Contractors completed repair work at the known siphon break location between August and November. That work included a substantial groundwater dewatering system to lower the water table to stabilize the ground for excavation. The broken pipe was also cleaned and inspected with CCTV equipment to assess its condition. Additional holes were discovered in the pipe during the inspection, the result being that a more extensive repair is needed in order to put the pipe back into service.

#### Rationale

Emergency Declarations exceeding \$175,000 require appropriate Committee and Council ratification.

#### **Thrive Lens Analysis**

This action advances the Thrive Outcome of Stewardship. Public financial resources will be invested efficiently and effectively to maintain and restore existing capacity to existing wastewater infrastructure which protects the region's natural resources.

#### **Funding**

The estimated cost for the emergency work is \$3,000,000. This will require a \$2,000,000 amendment to the original Emergency Declaration. This work will be funded out of the 2023 MCES Authorized Capital Program.

#### **Small Business Inclusion**

Due to the time-sensitive nature of the Emergency Declaration and the need for immediate work to be performed to protect public health and existing infrastructure, the Office of Equity and Equal Opportunity did not establish a small business goal. The application of a goal would significantly impact the timing of this project.

Describe the nature of the emergency situation.

On July 17th, 2023, Saint Paul Park & Recreation received a complaint from the Metro Mosquito Control District regarding a sewage spill/odor south of Shepard Road and east of 35E. Saint Paul Sewer Utility investigated the site and provided pictures and video and prepared the attached map. The spill appears to line up with the MCES siphon crossing from Lilydale/Mendota Heights. The spill was called into MCES Dispatch today around 1:30PM. MCES staff is onsite cleaning up spill material and will continue to work with all entities on the repair plan and any necessary traffic control and permitting requirements.

Explain why this situation is a present, immediate, and existing emergency.

Work is required to immediately protect public health and protect roadway and existing utility infrastructure. Explain how this emergency does or will affect the health, safety, or welfare of the public or the safety of

Metropolitan Council employees or facilities.

The spill potentially has negatively impacted public health and safety. A repair and cleanup is necessary to prevent any further damage.

Describe the supplies or services which must be acquired to remedy this emergency situation, including the estimated cost.

Excavation for interceptor repair, traffic control, spill cleanup services and minor surface restoration.

Contracting will likely be required for cleanup and repair of damaged pipe

Estimated Cost: \$1,000,000

Identify how you chose the contractor(s).

ECI was selected for the forcemain repair due to their availability relative to the other contractors in the area.

Based on the above information, an emergency situation exists within the meaning of the Council Procurement Policy. Carrying out the competitive bidding process and the technical requirements of the Council's Procurement Policy and awaiting Council declaration of an emergency and approval for the purchase of materials or supplies or the making of emergency repairs would significantly and unacceptably delay the commencement of repair work on the above-referenced project. The Metropolitan Council, by its Procurement Policy, has delegated authority to the Regional Administrator to declare an emergency on behalf of the Council in such cases. Therefore, I declare on behalf of the Metropolitan Council, that an emergency exists as described above and that the emergency situation requires the immediate purchase of materials or supplies or the making of emergency repairs. I authorize the General Manager/Division Director named above to let appropriate contracts and make payments for the purchase of materials or supplies or the making of repairs necessary to meet the emergency situation without advertising for bids, without meeting other technical requirements of Council Procurement Policy, and without prior approval of the Council. If the costs to correct the emergency situation total \$175,000 or more, I direct that this emergency declaration and any such contracts and/or payments be presented to the Metropolitan Council for formal ratification at its next meeting.
