Proposed Action

That the Metropolitan Council authorize its Regional Administrator to execute a Cooperative Construction Agreement with the City of Vadnais Heights for the design and construction of access improvements to Interceptor 1-VH-422 for an amount not to exceed \$900,000.

Background

The City has proposed a joint project to raise the grade between maintenance access structures to provide vehicular access. Both the City of Vadnais Height and MCES have sanitary sewer system infrastructure located in a wetland area. The soft soils of the wetland make accessing the maintenance access structures for cleaning, maintenance, and inspection extremely difficult for service vehicles.

Rationale

Both organizations would benefit from the improved access to their respective structures. Costs for engineering and construction would be split between MCES and the City proportionally. The project work would be contracted by the City with construction planned for 2024.

Council policy requires interagency agreements with expenditures valued at greater than \$500,000 to be approved by Council.

Funding

This project will be funded through local funding. Funding has been identified within the 2024 Capital Improvement Program.
