Summary of Community Development Commission Discussion/Questions

Jessica Lee presented the staff report to the Community Development Committee on April 15, 2024.

Council member Judy Johnson asked which two agencies didn't apply this time. Lee responded that the City of Bloomington and Dakota County didn't apply due to staffing capacity. Chair Robert Lilligren asked how the feedback from the review committee will be used next time. Lee responded that it will be incorporated into the next Notice of Funding Availability.

Council member Peter Lindstrom remarked that it would be great to present to the full Council when current grants have mostly closed to share lessons learned, what worked well, etc. Council member Johnson asked why many of the current projects have been extended. Lee responded that partly it was due to timing and the pandemic and construction delays, and partly because agencies have found that it takes a lot of work and time to get new programs started.

Motion by Council member Lindstrom, seconded by Council member Tori Carter. The committee voted unanimously to pass the proposed action.

Summary of Metropolitan Parks and Open Space Commission Discussion

Jessica Lee presented the staff report to the Metropolitan Parks and Open Space Commission on April 4, 2024.

Commissioner Cecily Harris asked to include MPOSC in a future presentation of existing equity grants and lessons learned. Commissioner Bob Moeller stressed the importance of awareness of the regional parks system in equity work.

Commissioner Monica Dillenburg asked about the two projects that received partial funding. Lee explained that one project had \$100,000 in ineligible costs because the agency was proposing a capital construction component outside of the regional park system. The second project was reduced by \$10,000 because the agency had reached their programming funding limit.

There was expressed support for funding all projects, and observations that the projects and program has matured since its inception.

Motion by Commissioner David Yakes, seconded by Commissioner Bob Moeller. The Commission voted unanimously to pass the proposed action.

Background

The 2040 Regional Parks Policy Plan commits the Council to develop a set-aside, competitive equity grant program to strengthen equitable use of the Regional Parks and Trails System. The Equity Grant Program was formally established in 2019 through a pilot program with capital funding that resulted in the awards for three Regional Park System equity projects. In 2021, the Council dedicated \$664,000 in Council bonds for capital projects and \$1,400,000 in parks interest earnings for programming or a mix of non-capital and capital projects. The competitive grant round resulted in the funding of 23 capital and non-capital projects.

Similar levels of funding have been set aside for the 2024 Competitive Equity Grant Program. \$658,000 is available in Council bonds for capital projects, and \$1,410,000 in parks interest earnings is available for programming/non-capital. The interest earnings may be used for capital projects if funds remain after awarding programming projects.

The Notice of Funding Availability (NOFA) was approved by the Council on October 25, 2023. The WebGrants application was open from November 1, 2023, to January 15, 2024. Eight Regional Park Implementing Agencies applied for 22 projects totaling \$2,075,500. A technical review committee comprised of members of the Metropolitan Parks and Open Space Commission, the

Community Development Committee, and Agency representatives met in February and again in March. Between meetings they individually read and scored each project. At the second meeting, the projects were discussed and ranked according to their scores. One project was deemed to have an ineligible component and the budget was reduced by \$100,000, which then resulted in enough funding for all projects. While some capital projects will need to be funded with interest earnings to accommodate funding all projects, none of the agencies went over their \$200,000 cap in either category of capital or noncapital requests except for one Agency, which will receive partial funding for one project as a result. The review committee agreed that all applications had merit and that they should all be funded. The project scores and funding amounts are shown below in Table 1, Funding Recommendations. Project summaries are available in Exhibit 1.

Rationale

The 2040 Regional Parks Policy Plan, Finance Chapter 8, Strategy 4 states that equity is a consideration in the Regional Parks and Trails System funding and investment. The equity grant program is one key Council strategy for advancing equity in the region.

Thrive Lens Analysis

The competitive equity grant program seeks to advance the *Thrive MSP 2040* outcome of equity by increasing the equitable usage of the Regional Parks and Trails System by all residents of the region.

Funding Up to \$2,068,000 is available in the authorized budget for the 2021 Equity Grant Program. This includes \$658,000 in Council capital bonds and \$1,410,000 in Parks Interest Earnings.
