Proposed Action

That the Council authorize its Regional Administrator to execute a MnDOT administered Grant Agreement 24I026 which will provides \$2,902,100 in matching funds from MnDOT's IIJA Discretionary Match Program and applied toward Metro Transit's awarded FTA FY23 Low or No Emissions grant.

Background

On June 26, 2023, Metro Transit was awarded an FTA Low or No Emission Grant worth \$17,532,900 with an additional commitment of local matching funds equaling \$2,902,100 for a total project cost of \$20,435,000. On November 9, 2023, Metro Transit was awarded state funding from the MnDOT IIJA Discretionary Match Program in the amount of \$2,902,100 which fully covers the local match requirement for the FY23 FTA Low or No Emission Grant. MnDOT has provided a draft grant agreement for the MnDOT IIJA Discretionary Match Program which requires negotiation and execution to proceed.

Rationale

Income Grants Policy FM 15-1 requires agreements exceeding \$500,000 be approved by the Council

Funding

This grant agreement enables the Council to receive \$2,902,100 from MnDOT to match \$17,532,900 in awarded Federal funds for the FTA FY23 Low or No Emissions grant. Funding will be used in projects 65320 Bus Replacements and 64707 Electric Bus Infrastructure.
