METRO Blue Line Extension (BLE) – Authorize Municipal Consent Joint Public Hearing

### Proposed Action

That the Metropolitan Council:

- Authorize a joint Municipal Consent public hearing with Hennepin County Regional Railroad Authority and Hennepin County on August 26, 2024, at 6:00pm at NorthPoint Health and Wellness Conference Center, 1256 Penn Avenue N, Suite 5200, Minneapolis, MN 55411 to discuss the physical design components of the preliminary design plans for the METRO Blue Line Extension light rail transit project; and
- Direct staff to prepare Blue Line Extension Municipal Consent Plans and submit them to Hennepin County and the cities of Minneapolis, Robbinsdale, Crystal, and Brooklyn Park.

Metro Transit Deputy General Manager - Capital Programs Nick Thompson presented this item. Chair Barber asked if there is a role for Council members to play at the public hearing. ### Proposed Action

That the Metropolitan Council:

- Authorize a joint Municipal Consent public hearing with Hennepin County Regional Railroad Authority and Hennepin County on August 24, 26,\* 2024, at 6:00pm at NorthPoint Health and Wellness Conference Center, 1256 Penn Avenue N, Suite 5200, Minneapolis, MN 55411 to discuss the physical design components of the preliminary design plans for the METRO Blue Line Extension light rail transit project; and
- Direct staff to prepare Blue Line Extension Municipal Consent Plans and submit them to Hennepin County and the cities of Minneapolis, Robbinsdale, Crystal, and Brooklyn Park.

### Background

The proposed Blue Line Extension light rail transit project (Project) will extend the existing Blue Line from Target Field Station and connect and serve the communities of Minneapolis, Robbinsdale, Crystal, and Brooklyn Park.

The Project received approval from the Federal Transit Administration (FTA) to commence the Capital Investment Grant Project Development Phase on August 22, 2014. Following this, the Final Environmental Impact Statement was issued in July 2016, with the FTA granting a Record of Decision in September 2016. Subsequently, on January 19, 2017, the Project transitioned into the Engineering Phase. At its meeting on June 22, 2022, the Metropolitan Council took action to advance a proposed route modification which does not utilize freight rail right-of-way, as outlined in the 2022 Route Modification Report (see Business Item 2022-158). As of March 2024, project staff has advanced the engineering and design of the route and stations to 30% design completion.

Under Minnesota law, the physical design components of a proposed light rail transit facility in the metropolitan area must go through a Municipal Consent process before final design plans can be prepared.

The Metropolitan Council will submit to Hennepin County and the cities along the proposed route the physical design components of the preliminary design plans for the Project (Plans) and it will

conduct a joint Municipal Consent public hearing with Hennepin County Regional Railroad Authority on the Plans. This public hearing will also serve as the public hearing for Hennepin County. The hearing will take place on August 24, 2024, at NorthPoint Health and Wellness Conference Center, 1256 Penn Avenue N, Suite 5200, Minneapolis, MN 55411 at 6 pm. Residents can provide public comments from the date of the hearing to October 10, 2024.

### **Rationale**

Minnesota Statutes Section 473.3994 outlines the procedure for Municipal Consent for each proposed light rail transit (LRT) facility in the metropolitan area. Before the final design plans are prepared for an LRT project, the Metropolitan Council and the Hennepin County Regional Railroad Authority must hold a joint public hearing on the Plans to ensure that affected parties have an opportunity to present their views at the hearing. At least 30 days before the joint hearing the Metropolitan Council will submit the Plans to each city or county in which the route is proposed to be located. Within 45 days after the joint hearing, each city and county shall review and approve or disapprove the Plans for the route. A local unit of government that disapproves the Plans shall describe specific amendments to the Plans that would cause the local unit to withdraw its disapproval.
