Proposed Action

That the Metropolitan Council:

- Concur with the Transportation Advisory Board (TAB) action to select 59 federally funded transportation projects through the Regional Solicitation process and include these projects in Transportation Improvement Programs (TIP) in the future; and
- Authorize the Regional Administrator to enter into grants for 17 projects selected by the Transportation Advisory Board to be funded with Active Transportation sales tax funds.

Background

In Fall of 2023, the Council released its biennial Regional Solicitation to award federal transportation funding to roadway, transit, and bicycle/pedestrian projects throughout the metropolitan area. The Regional Solicitation process traditionally distributes federal Surface Transportation Block Grant (STBG) Program, Transportation Alternatives (TA), and Congestion Mitigation Air Quality (CMAQ) funds received by the Council as the region's Metropolitan Planning Organization (MPO). This action also includes distribution of the more recently established Carbon Reduction Program (CRP) and Promoting Resilient Operations for Transformative, Efficient, and Cost-Saving Transportation (PROTECT) Program.

A total of 127 applications were submitted, with most scored through an open and transparent process by over 50 technical expert volunteers representing regional transportation agencies and local governments. At its July 17, 2024, meeting, TAB selected and approved forwarding a program of projects totaling \$264 million in federal STBG, TA, CMAQ, CRP and PROTECT funds funding 59 projects for the Council's concurrence. The funding option selected by TAB, called the "Hybrid" option, was approved unanimously because it funded all projects included in safety- and bike/ped-themed options along with an additional transit project and two additional Safe Routes to School projects. The federal funds will leverage an additional \$262 million in local matching funds for a total regional investment of \$526 million.

During development of the 2024 Regional Solicitation, the state legislature approved Active Transportation regional sales tax funding that includes a portion to be distributed by the TAB. The TAB then established a working group to plan for distribution of the funding. The working group recommended, and TAB approved, funding 17 projects to serve as a "pilot" for Council staff to manage the grants for the projects. These projects, because they are not funded with federal funds and are not regionally significant, will not be included in the TIP. However, they were selected through the scoring of the Regional Solicitation and therefore are reflective of that process. In terms of prioritization the 17 projects funded through the Active Transportation Projects are not distinguishable from those that will receive federal funding. Altogether the 76 funded projects will receive \$264 million in federal funding, \$19 million in Active Transportation funding, and \$276 million in local funding for a total investment of \$559 million. These projects include investments within the borders of all seven counties and 52 cities and townships.

Rationale

The Regional Solicitation is a key responsibility of the TAB. Through this process, federal funds are directed to a variety of locally initiated projects that meet regional transportation goals. The Regional Solicitation is part of the Metropolitan Council's federally required continuing, comprehensive, and cooperative transportation planning process for the Twin Cities Metropolitan Area. The agreed upon process for allocating the federal STBG, TA, and CMAQ funds through the Regional Solicitation is documented in a Memorandum of Understanding between the Council and MnDOT.

Thrive Lens Analysis

This action promotes:

- Stewardship by leveraging federal dollars to support local investment.
- Prosperity by funding key access projects that will move people and goods through the region more efficiently.
- Equity by incorporating an equity scoring measure in all application categories and encouraging projects to be developed with an equity lens.

Funding

The federal STBG, TA, CMAQ, Carbon Reduction Program, and PROTECT funding for the recommended program of projects, including overprogramming, totals \$364 million. All projects must be matched with at least 20% local funds from non-federal funding sources. The project applicants commit to providing the necessary match and many applicants provide funding beyond the required 20% to fully fund the projects.

Small Business Inclusion

The Minnesota Department of Transportation's State Aid office, MTS Grants Management, and Metro Transit Grants Management will oversee the federal requirements for the federally funded projects, including the DBE requirement.
