That the Metropolitan Council:

1. Approve the 2024 Regional Parks System Fishing Piers Grant Program Notice of Funding Availability attached to this report.
2. Approve the funding and awarding of four grants selected through a lottery as outlined in the NOFA.
3. ~~Consider using Council funds to match state funding to expand the fishing pier opportunity to more residents.~~

### Summary of Community Development Commission Discussion/Questions

Jessica Lee presented the staff report to the Community Development Committee on October 21, 2024. In her presentation, she explained that the third action added by the Metropolitan Parks and Open Space Commission (MPOSC) is not a viable option for this funding opportunity due to timeline restrictions with both the appropriation and the Council budgeting process.

Chair Robert Lilligren asked for clarification of what staff were proposing for the third action. Council Member Susan Vento reiterated that the third action was added by MPOSC and she explained that it would be nice to have a mechanism in future Council budgets to allow for Council funds to match future state appropriations like this one. Unfortunately, we are not able to secure additional Council funding in the timeline required for using these funds. Emmett Mullin, Parks Manager, added that he spoke with the Community Development budget director who confirmed that using Council funds to match this appropriation wouldn't be possible in the timeline available. He also added that the Council's traditional funding sources like the bonding program do allow for fishing piers.

Council Member Wendy Wulff asked for confirmation that the fishing piers must be on lakes, and that all agencies have lakes in their systems. Lee confirmed this was correct. Wulff expressed appreciation for the funding and added that it doesn't make sense to her to expand the Council's bonding authority under the current scenario.

Vento motioned to approve actions one and two, Wulff seconded, and the Committee voted unanimously to pass the actions.

### Summary of Metropolitan Parks and Open Space Commission Discussion

Emmett Mullin presented the staff report to the Metropolitan Parks and Open Space Commission on October 3, 2024.

Commissioner David Yakes asked whether this was a one-time appropriation or whether it could be a permanent program. Mullin responded that currently it is a one-time appropriation.

Commissioner Bob Moeller asked about what it meant that the proposed fishing pier be consistent with the Council-approved long-range plan? Mullin said that the long-range plans are usually strategic documents that identify a broad development concept, for instance to provide access to water resources and recreational opportunities.

Commissioner Yakes inquired about whether the fishing piers could be multi-use, beyond fishing, allowing other recreational activities like swimming or picnicking. Three Rivers Park District's Assistant Superintendent Jonathan Vlaming stated that while fishing piers often have railings to enable safe fishing, people use them for other activities such as wildlife viewing.

Vlaming shared that he reached out to the nine other park implementing agencies and determined that at least six other agencies were planning to apply for fishing pier funds. Recognizing that fishing piers advance equitable access would it be possible for the Council to match these funds?

Commissioner Anthony Taylor expressed support for this idea, having the Council match the state funds and enable all interested regional park implementing to participate in the program.

Council Member Susan Vento committed to bringing this request to the Community Development Committee, agreeing that fishing piers are an inclusive and equitable investment.

Council Member Bob Moeller, with Commissioner Dillenburg's support, requested adding a third action to this report, for the Council to consider matching the state funding to expand the fishing pier opportunity to more residents.

Next, Chair Tony Yarusso refined the motion language.

Council Member Vento requested that Council and Agency staff work with the Minnesota Departments of Natural Resources and Health to promote safe consumption of fish. She

encouraged the agencies/Council to get ahead of this communication challenge with our region's anglers, particularly with concerns about PFAS (per- and polyfluoroalkyl) contamination.

Motion by Commissioner Moeller, seconded by Commissioner Taylor, the Commission voted unanimously to pass the amended action.

### Proposed Action

That the Metropolitan Council:

1. Approve the 2024 Regional Parks System Fishing Piers Grant Program Notice of Funding Availability attached to this report.
2. Approve the funding and awarding of four grants selected through a lottery as outlined in the NOFA.

### Background

The Minnesota Legislature appropriated \$500,000 for new fishing piers on lakes in the Metropolitan Regional Parks and Trails System to increase fishing opportunities. This is a one-time appropriation, and funds must be used by June 30, 2026. The legislation requires the Council to solicit applications but does not require a competitive grant review process.

Council staff reached out to the DNR and also spoke to the implementing agencies to estimate the average cost of a fishing pier. It was determined that a quality fishing pier, along with minimum access features, would cost somewhere between \$100,000 and \$175,000. Council staff proposed to the implementing agencies to fund three to five eligible grants of equal value through a randomized lottery held at a future Metropolitan Parks and Open Space Commission (MPOSC) meeting. The group's consensus recommendation was that \$125,000 would be a good project amount, thus funding four equal grants totaling \$500,000.

Projects must meet specific criteria in order to be included in the lottery. These criteria are described in the attached draft Notice of Funding Availability (NOFA).

Staff shared the draft NOFA at the September Metropolitan Parks and Open Space Commission meeting and was encouraged to move forward and bring the NOFA for approval in October.

## Rationale

The Minnesota Legislature appropriated \$500,000 for new fishing piers on lakes in the Metropolitan Regional Parks System. This NOFA outlines the program and process for spending those funds.

## Thrive Lens Analysis

This grant program is consistent with *Thrive MSP 2040*'s Livability and Stewardship outcomes. New fishing piers will increase opportunities for people to get outdoors and connect to nature.

## Funding

Funding is provided by the Minnesota State Legislature through an appropriation passed in the 2024 legislative session. This new program has these funds available in the Council's Authorized Capital Program. Agencies may provide additional funds for projects that exceed \$125,000.

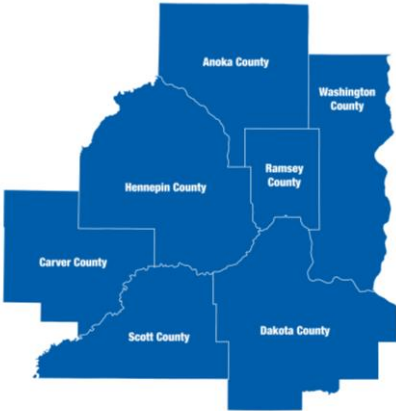

The Council operates the regional bus and rail system, collects and treats wastewater, coordinates regional water resources, plans and helps fund regional parks, and administers federal funds that provide housing opportunities for low- and moderate-income individuals and families. The 17-member Council board is appointed by and serves at the pleasure of the governor.

## 2024 Notice of Funding Availability (NOFA)

This 2024 Notice of Funding Availability (NOFA) describes the Metropolitan Council's intentions for the one-time legislatively directed Regional Parks System Fishing Piers Grant Program. Specifically, this notice:

- Establishes the amount of funding available and the limits that apply to individual awards.
- Sets the schedule for application submittal, review, and award.
- Describes the criteria the Metropolitan Council will use in project selection.
- Defines who is eligible to apply.

### *Background and Purpose*

The 2024 legislative session appropriated \$500,000 for grants to Regional Park Implementing Agencies for new fishing piers to increase fishing opportunities on lakes in the metropolitan parks system. The Metropolitan Council is tasked with soliciting proposals from the implementing agencies. These funds expire June 30, 2026.

### *Eligible Applicants*

By state statute<sup>1</sup>, applicants must be a regional park implementing agency, defined as the counties of Anoka, Carver, Dakota, Ramsey, Scott and Washington, the cities of Saint Paul and Bloomington, the Minneapolis Park and Recreation Board, and the Three Rivers Park District.<sup>2</sup> Regional park implementing agencies are welcome to collaborate on proposals. Individuals and/or other governmental, private, or nonprofit entities are not eligible to apply, but are encouraged to be included as project partners with regional park implementing agencies.

### *Available Funds and Award Limits for 2024*

- \$500,000 in State funds is available for new fishing piers.
- Agencies are allowed to submit one application each for \$125,000. If the total project cost is more than \$125,000, agencies must provide the additional funding.
- A lottery will be held at a Metropolitan Parks and Open Space Commission (MPOSC) meeting to select four awards from the pool of eligible applications.
- The Council reserves the right to award less than the available funding.
- Grants are reimbursement-based.

### *Eligible Uses of Funds and Criteria*

Grant proposals must meet all of the below criteria to be considered for funding.

- Proposals must be for new fishing piers.
- Proposals must clearly demonstrate a need and describe how the fishing pier will increase fishing opportunities.
- Proposals must address one or more equity focus area (age, race, ethnicity, income, national origin or ability).
- The proposal must demonstrate how a new fishing pier will contribute to additional programming opportunities and awareness building for the regional parks and trails system.

- Projects must be ready to start so that they can be completed by June 30, 2026.
- Projects must be within the boundaries of the Regional Parks and Trails System, consistent with the *2040 Regional Parks Policy Plan*, consistent with a Council-approved long-range plan, and compliant with the Americans with Disabilities Act (ADA).
- Project must be approved by the Agency’s locally elected board either individually or as part of a local capital improvement plan before a grant agreement is executed.

### *Funding Schedule*

October 2024	NOFA brought through the Council process for approval and to authorize awarding four eligible projects after the MPOSC lottery
November 2024	NOFA posted on Council website and application opens
January 2025	Applications due by 4:00 P.M. on January 10, 2025 (must be submitted via <a href="#">WebGrants</a> )
January 2025	Staff review projects for eligibility
February 2025	Lottery held at the February 6, 2025 MPOSC meeting
February 2025	Grant agreements sent out

These dates are subject to change.

### *Proposal Review Process*

Council staff will review all proposals to ensure completeness and eligibility. Council staff are available to answer agency questions throughout the application process. Applications must meet each of the criteria listed above in order to be eligible for the lottery. The MPOSC chair will select four applications at random at a public MPOSC meeting.

### *Grant Terms*

Grants will expire June 30, 2026, with no extensions possible. All costs eligible for reimbursement must be incurred during the grant term and all costs must be submitted within 90 days after the end of the grant term. Unspent grant funds will revert to the State.
