Proposed Action

That the Metropolitan Council authorize the Regional Administrator to execute an amendment for contract 19P049A with Transportation Plus to add \$650,000 for a total contract value not to exceed amount of \$6,876,754.

Background

In September 2023, the Metropolitan Council authorized the Regional Administrator to negotiate and execute Amendment Two to Contract 19P049A with Transportation Plus to extend the contract through year six while also expanding service hours to comply with Min Law Chapter 68, Sec. 121.

Transportation Plus has been delivering on-demand rides to Metro Mobility clients under this contract since October 2020. Since the service expansion in 2023, the Council subsidizes up to \$20 per trip plus additional surcharges ranging from \$25 - \$55 for trips that occur during the expanded pilot program hours. The cost of the contract has outpaced original projections due to increased Council subsidy per trip, and increased ridership. In January 2024, an additional \$2,850,000, previously authorized by the Council, was added through Amendment Three and an additional \$1,500,000 in September 2024.

The Council is currently procuring new On-Demand service contract(s) through business item 2024-261. It is likely that new contract(s) will not be executed by December 31, 2024, when contract 19P049A is set to expire. Amendment 5 provides the additional funds needed to extend the existing contract and avoid a disruption to service while new agreements are finalized.

Rationale

Council Policy requires amendments exceeding 10% of the original authorized contract value be approved by the Council for a services contract if the cumulative value exceeds \$500,000.

Thrive Lens Analysis

This contract will advance the Thrive outcome of Livability by providing persons with disabilities with safe and reliable transportation will enhance quality of life in the region and maintain a higher level of independence.

Funding

Funding for this service is included in the 2025 Metro Mobility budget.
