Call to order

1. 2024-116: METRO Green Line Extension Civil Construction Cumulative Change Order Authority Increase, Contract 15P307A

Proposed Action: That the Metropolitan Council authorize 2.98% (\$23.8 million) in cumulative change order authority for contract 15P307A with Lunda McCrossan Joint Venture, resulting in 36.29% (\$290.2 million) total cumulative change order authority.

2. **2024-221:** Minnesota River Bluffs Regional Trail, Park Acquisition Opportunity Fund Award (CCRRA), Carver County

Proposed Action: That the Metropolitan Council:

Proposed Action: That the Metropolitan Council authorize the Regional Administrator to negotiate and execute an amendment to contract 21P271 with RailPros for freight rail flagging services in the amount of \$775,936, for a total contract amount not to exceed \$1,326,559.

7. **2024-285:** METRO Green Line Extension Advanced Design Consultant, Contract 14P125 – Amendment No. 16

16. **2024-308:** Elm Creek Park Reserve, Park Acquisition Opportunity Fund Award (Lasher), Three Rivers Park District

Proposed Action: That the Metropolitan Council:

Approve a grant of up to \$420,000 from the Park Acquisition Opportunity Fund to Three Rivers Park District to acquire a 2.8-acre parcel located at 12651 Elm Creek Crossing in Champlin, MN, for the Elm Creek Park Reserve.

Authorize the Executive Director of Community Development to execute the grant agreement and restrictive covenant on behalf of the Council.

17. **2024-309:** Diamond Lake Regional Trail, Park Acquisition Opportunity Fund Award (Boggs), Three Rivers Park District

Proposed Action: That the Metropolitan Council:

- Approve a grant of up to \$525,000 from the Park Acquisition Opportunity Fund to Three Rivers Park District to acquire a 23.2-acre parcel located at 17700 117th Ave N in Dayton, MN, for the Diamond Lake Regional Trail.

Proposed Action: That the Metropolitan Council authorize the Reginal Administrator to negotiate and execute Agreement 24I013 ("Agreement") with the City of St. Paul ("City") for construction of METRO G Line BRT station platforms in conjunction with the City's Robert Street Reconstruction Project in an amount not to exceed \$1,400,000.

23. 2024-319: Metro Mobility On Demand Services, Contract 19P049A - Amendment 5

Proposed Action: That the Metropolitan Council authorize the Regional Administrator to execute an amendment for contract 19P049A with Transportation Plus to add \$650,000 for a total contract value not to exceed amount of \$6,876,754.

Absent an agreement between the replacement service municipalities, the Regional Administrator shall determine the amount to be allocated to a replacement service municipality.
- The Metropolitan Council shall publish the Transit Funding Allocation policy, implementing procedures, financial information, and reporting requirements on its website.
