#### **Background**

The Facility Plan recommends the following project to restore the integrity, minimize wastewater spill potential, and maintain public health, safety and welfare. Three types of improvements that will take place include cleaning the existing interceptor, rehabilitation through trenchless methods and replacement or rehabilitation of several existing structures.

#### Rationale

Public Facilities Authority (PFA) loan funding eligibility requires formal adoption of the Facility Plan by resolution (attached) following a public hearing on the draft Facility Plan.
