Proposed Action

That the Metropolitan Council adopt the Facility Plan for the Coon Rapids Interceptor Rehabilitation, Project Number 808609, per the attached Resolution Number 2025-1.

Background

The Facility Plan recommends the following project restore the integrity, minimize wastewater spill potential, and maintain public health, safety, and welfare. Three types of improvements that will take place include cleaning the existing interceptor, rehabilitation through trenchless methods, and replacement or rehabilitation of several existing structures.

Rationale

Public Facilities Authority (PFA) loan funding eligibility requires formal adoption of the Facility Plan by resolution (attached) following a public hearing on the draft Facility Plan.
