Dakota Land, Water, and People Acknowledgment

The Metropolitan Council acknowledges that the land we currently call Minnesota and specifically the seven-county region is the ancestral homeland of the Dakota Oyate who are present and active contributors to our thriving region. As part of the Metropolitan Council's commitment to address the unresolved legacy of genocide, dispossession, and settler colonialism and the fact that government institutions, including the Metropolitan Council, benefitted economically, politically, and institutionally after the forceable removal of the Dakota Oyate, the Metropolitan Council is dedicated to instilling Land, Water, and People Commitments in regional policy. These commitments support the Dakota Oyate, the eleven federally recognized Tribes in Minnesota, Ho-Chunk Nation, and the American Indian Communities representing over 150 diverse Tribal Nations that call the seven-county region home.

Call to order

A quorum being present, Council Chair Zelle called the regular meeting of the Metropolitan Council to order at 4:01 p.m.

Approval of minutes

Peter Wilfahrt and Gillian Greenberg provided an update of the draft Comprehensive Climate Action Plan (CCAP), which will be open for public comment. Staff walked through the greenhouse gas emissions (GHG) inventory data by sectors and projections. Staff also discussed workforce analysis, which is a required component of the Climate Pollution Reduction grant. Staff will continue to engage with community organizations involved in the Community Climate Collaboration as well as Steering Committee.

For the public comment period, an online portal for feedback will be available on the Council's website. Council efforts will align with how the Council collects public comments for other areas of the Council.

Chair Barber thanked Council Members for their support and leadership. In addition, Chair Barber thanked staff for their help with onboarding during this transition.

As a member of the Metropolitan Urban Indians Directors, Council Member Lilligren attended the State Urban Indian Communities Legislative Summit. This summit is the first ever event that state agencies banded together to engage specifically with urban Indian communities. Sponsors and participants came from different parts of the state, particularly those from non-federally recognized regions such as Duluth.

Council Member Chamblis shared that the September 17, 2025 Community of the Whole meeting took place in Champlin, MN. Mayors from Champlin, Columbia Heights and Brooklyn Park were part of the discussion panels with Council Members Chamblis and Morales. The theme was focused on planning and the Council heard from city leaders about their needs and what cities are looking forward to and how to partner with the Council.

Council Member Jenkins highlighted his participation in Great Day in Transit this week. Council Member Jenkins gave a shout-out to frontline staff who greeted everyone. They were cheerful and are great transit representatives for the region.
