Proposed action

The Metropolitan Council authorize the Regional Administrator to negotiate and execute contract 24P267 with Waste Management Inc. to provide solid waste and recycling services in the amount of \$1,100,000.

Background

This contract will provide solid waste collection services for various Metro Transit facilities located throughout the Dakota, Hennepin, Ramsey, Scott, and Sherburne counties that extends beyond the historic task of collecting waste to be landfilled, recycled, or composted with a partnership that is committed to assisting in reducing costs, and improving diversion rates.

A Request for Proposals was issued on July 3, 2025. A pre-proposal meeting was hosted by Council staff that outlined the solicitation requirements, discussed project specifications and responded to plan holder inquires. There were fourteen registered plan holders, nine prime proposers, one subcontractor, four plan rooms, and six of plan holders identified as minority, woman, veteran, small or disadvantaged business enterprises. The Council received three proposals on July 24, 2025, to be evaluated for the consideration of award and used proposer quality, proposer qualifications, experience, service delivery plan, key personnel, and price as the criteria for evaluation. The evaluation panel reached consensus that the proposal submitted by Waste Management Inc. is the most advantageous to the Council and recommend for award. The performance period for this contract will be 36 months.

Rationale

The execution of a professional service contract exceeding \$500,000 requires Council approval.

Thrive lens analysis

On Feb. 12, 2025, the Council adopted Imagine 2050, which builds on policy direction in Thrive MSP 2040. Under the Thrive lens, this action supports Sustainability and Stewardship by ensuring the waste byproducts of our support and public operations are disposed of properly protect lands and water supplies. By separating out recyclable and organic materials we minimize the impact on

the region's solid waste disposal facilities.

Funding

Funds are budgeted for this work in Metro Transit's Council Authorized Operating Budget.

Small business inclusion

The Office of Equity and Equal Opportunity (OEEO) thoroughly reviewed this procurement for Metropolitan Council Underutilized Business (MCUB) opportunities in accordance with federal and state laws and regulations as well as contract specifications. Upon conclusion of OEEO's research and analysis, no MCUB goal was set
