Risk Management Information System, Contract 19P142 – Amendment 3

Proposed action

That the Metropolitan Council authorize the Regional Administrator to execute an amendment to contract 19P142 with Origami Risk, LLC that will add up to \$919,908.34 for software maintenance and support for a total contract amount not to exceed \$ 4,735,539.17.

Summary of Management Committee discussion/questions

Information Services Manager Josh Alswager, Director of Risk Management Ray Engler, and Metro Transit Chief Safety Officer Andrew Brody presented the item. Mr. Alswager provided an initial overview of the request. Mr. Engler provide background on how the Met Council uses the software system for claims administration, insurance and total cost of risk management. Finally, Mr. Brody provide more specifics about the vision of collaboration using the same system to create a data rich environment encompassing more safety related aspects.

Committee members expressed strong support of the proposal. A question was asked about the need for customization for the additional module. Mr. Alswager did state there will be implementation costs to integrate it into current systems.

Proposed action

That the Metropolitan Council authorize the Regional Administrator to execute an amendment to contract 19P142 with Origami Risk, LLC that will add up to \$919,908.34 for software maintenance and support for a total contract amount not to exceed \$ 4,735,539.17.

Background

Origami Risk, LLC provides the Council with a Risk Management Information System. This enterprise system ensures accurate and consistent tracking and reporting of the Council's insurance claims, incidents, policies, locations and exposures. The current five-year contract has a term which ends on April 20, 2030.

This amendment request is to add four additional software modules which include Safety Management, Process Safety Management, Occupational Health, and Chemicals and Materials Management. These safety-related modules will be utilized by Metro Transit and Environmental Services. Professional implementation services are included in the scope of the amendment.

Rationale

Council Policy requires amendments exceeding 10% of the original authorized contract value be approved by the Council if the cumulative value exceeds \$500,000. Amendments to contracts that exceed 10% of the original value constitute sole source procurements requiring Council approval.

Thrive lens analysis

The Council adopted Imagine 2050 on February 12, 2025, which builds on policy direction in Thrive MSP 2040. Under the Thrive lens, this action advances the outcome of Stewardship and Sustainability by ensuring reliability, resilience, security and cost-effectiveness of the Council's computers, servers and cloud services.

Funding

Funding for this enterprise agreement is included in the Information Services operating budget. First year software licensing and implementation services for the additional modules are being paid for by Metro Transit.

Small business inclusion

This contract is being procured through a sole source. Therefore, the Office of Equity and Equal Opportunity did not assign a Metropolitan Council Underutilized Business (MCUB) goal.
