Proposed Action

That the Metropolitan Council ratify the attached *Justification for and Declaration of Emergency* for Repairs to Eagan Interceptor 3-ET-37.

Background

Televised inspection of Eagan Interceptor 3-ET-37 has recently revealed that the facility is severely corroded and requires immediate rehabilitation. These facilities were constructed in 1967 and are located adjacent to and under I-494 and in close proximity to the environmentally sensitive area near the Minnesota River. A portion of the deteriorated section is under the freeway and will be realigned outside of the roadway to eliminate future risk to the public.

Rationale

Metropolitan Council has delegated authority to the Regional Administrator to declare emergencies on behalf of the Council when the health, safety or welfare of the public is compromised or potentially compromised, and immediate action is required to address the emergency. The emergency declaration is then presented to the appropriate implementation committee for approval, and placed on a following Council consent list for formal ratification.

Funding

The cost of the repair is estimated at \$2,500,000 to come from the 2013 Capital Program, Project No. 809060.

Justification for and Declaration of Emergency

"A declared public emergency is an emergency situation in which the health, safety or welfare of the public or the safety of Metropolitan Council employees or facilities is compromised or potentially compromised and requires immediate action

I REQUEST THAT A PUBLIC EMERGENCY BE DECLARED, BASED UPON THE FOLLOWING:	
Describe the nature of the emergency situation:	Interceptor 3-ET-37 located in Eagan is in severely deteriorated condition requiring immediate rehabilitation. Hydrogen sulfide has caused severe corrosion of the concrete pipe.
Explain why this situation is a present, immediate, and existing emergency:	This interceptor is parallel to and under I-494 between Pilot Knob Rd and TH 13. Due to the sensitive location of this facility and potential impacts, it should be rehabilitated or replaced immediately.
Explain how this emergency does or will affect the healthy, safety, or welfare of the public or the safety of Metropolitan Council employees or facilities:	Collapse of this pipe would result in a raw sewage spill which could adversely impact public health, the environment or possibly I-494 and it's traffic.

Describe the supplies or services which must be acquired to remedy this emergency situation, including the estimated cost:	It is anticipated that complete replacement of approximately 2,500 feet of pipe and realignment of the portion under the freeway will be required.
