#### **Background**

In cooperation with the Minnesota Department of Natural Resources and the Greater Minnesota Parks and Trails Commission, the Metropolitan Council, with our ten regional park implementing agencies, is sponsoring a series of eight Regional Parks and Trails Legacy Celebrations across Minnesota. The first one will be held at Silverwood Park in St. Anthony on Saturday, January 27, 2018 from 1:00 – 4:00 PM.

These events help mark the 10-year milestone of the passage of the Clean Water, Land and Legacy Amendment. The day will be filled with family-friendly activities, celebrating Parks and Trails Legacy accomplishments, providing opportunities to learn about the Legacy Amendment and gather input on past Parks and Trails Legacy projects as well as future investments.

Governor Mark Dayton has been invited to help celebrate this first event at Silverwood Park. Three Rivers Park District, who owns and operates the park, will be on hand, along with staff from the other nine agencies, the Department of Natural Resources and the Greater Minnesota Parks and Trails Commission.

This is an all ages, all abilities occasion, so whether you're an avid adventurer or a novice, we hope you will join us to make this first event a success.

## **Funding**

Funding for the Parks and Trails Legacy Celebrations is derived from the Parks and Trails Legacy Funds that are dedicated to support, "Coordination Among Partners" activities, as outlined in the 25-year Parks and Trails Legacy Plan. This source of funding is administered by the Minnesota Department of Natural Resources, in coordination with the Metropolitan Council and the Greater Minnesota Parks and Trails Commission.
