Background

The 2040 Regional Parks Policy Plan commits the Council to developing a set-aside, competitive equity grant program in 2019. This program is designed to strengthen equitable usage of the Regional Parks System. To develop this grant program, the Council worked in close collaboration with Regional Parks Implementing Agencies, community-based organizations, advocacy groups, and other partners to formulate criteria and measures for awarding grants to Regional Parks Implementing Agencies for projects aimed at advancing equitable usage of the Regional Parks System.

Recommendation

Regional Parks Implementing Agencies submitted applications in August of 2019, which were then reviewed internally for eligibility and completeness. A formal review committee met on October 17, 2019 to receive the applications and discuss the pilot program and process. This review committee was comprised of representatives from the Metropolitan Parks and Open Space Commission, the Community Development Committee, and the Equity Advisory Committee. After the first meeting, committee members reviewed each application on their own and provided scores to Council staff. On November 5th, the committee met again to discuss their scores and develop a funding recommendation, which is shown in Table 1:

There is \$300,000 for the Equity Grant Program in the Council's adopted 2019 budget. The <u>Regional</u> <u>Parks System Competitive Equity Grant Program 2019 Fund Distribution Plan</u> also states that the Council may award up to an additional \$331,000 in 2020 regional bonds during this initial round if the quantity and quality of applications are sufficiently robust.

The initial round received 14 eligible applications requesting \$1,256,755, and 3 have been recommended for funding for a total of \$300,000. The review committee began their deliberations by commenting on the quality and thoughtfulness of all the applications. In the spirit of a pilot program, the committee recommends using only the \$300,000 from 2019, with the desire to use lessons learned from this first year to improve the program for the next cycle.

The review committee provided feedback for the regional park implementing agencies who proposed projects that were not included in the funding recommendation. The review committee encourages these agencies to consider this feedback and refine their projects for future submission. Projects which were not selected for funding are shown in Table 2.
