


Parks & Open Space



Regional Parks System

- Over 64 million visits in 2021
- 56 regional parks & parks reserves totaling more than 54,000 acres
- 55 regional trails, with over 415 miles of interconnected trails
- 8 special recreation features
- 10 regional park implementing agency partners



Establishment of MPOSC



Minn. Stat. §§ 473.302 and 473.303

 Establish the Metropolitan Parks and Open Space Commission as an agency of the Council

 Advise the Council on setting policy in the Regional Parks System to acquire, preserve, protect and develop regional recreational open space for public use

Master Planning



Minn. Stat. § 473.313 Master Plans

 The Metropolitan Council shall review master plans with the advice of the commission for consistency with the Regional Parks Policy Plan

Master Plans set vision and are local implementation of policy.

- MPOSC sets policy through development of the Regional Parks Policy Plan.
- Decennial update of the Regional Development Guide and Parks Policy Plan


Grants for Recreation Open Space



M.S. 473.315 Grants for Recreation Open Space

The Metropolitan Council with the advice of the commission may make grants, from any funds available to it for recreation open space purposes to any implementing agency, to cover the cost or any portion of the cost of acquiring or developing the regional recreation open space in accordance with the policy plan

Regional Parks System Revenue



State & Council Funding

- Parks and Trails Legacy Fund (Legacy)
 - Includes Statutory 10% set-aside
- Environmental & Natural Resources Trust Fund (ENRTF)
 - Support for Park Acquisition Opportunity Fund Program
- State of Minnesota Bonds
- Council Bonds
 - Up to \$40M outstanding
 - Match \$2 Council to every \$3 State.
- Operations and Maintenance Funding
- Interest Earnings

- Grant programs are funded by multiple state sources and Council bonds
- Council passes through 100% of state funding
- Current portfolio is 195 active projects valued at ~ \$133M
- \$234M in grants are programmed in the current Council Authorized Capital Improvement Program (2022-2027)

Advise planning and funding


- Agencies provide system-wide overviews of projects, including equity highlights






