
# **OVERVIEW**

## **PLAN VISION for Three Rivers**

 To connect Hennepin County first-tier suburb community members with nature every day. One way to do this is to focus on bringing parks, trails and nature-based offerings to where people live.

## PRINCIPAL PLAN GOAL

#### **BRIDGING INITIATIVES**

Bridging Initiatives are special recreation features that are intended to attract and introduce new outdoor recreation users who are underrepresented to the Regional Park System and help to address inequities that contribute to lower participation rates through prototyping new, innovative and creative ideas.

Bridging Initiatives can take a physical site form through **Bridging Parks** - or can be mobile by delivering nature-based **Bridging Programs** including recreational offerings, opportunities, and events - or can be individual **Bridging Projects** that assist in the delivery of Bridging Programs.

In all scenarios, Three Rivers can either be the lead agency or a supporting facilitator through partnerships with cities, agencies, non-profits, existing recreation providers, or community groups.

## Bridging **PARKS**

#### Overview

Bridging Parks are physical, standalone sites that are nature-based land holdings (including but not limited to; existing local parks, properties with natural resources potential/value etc) or sites nested within an existing regional park, park reserve, special recreation feature or regional trail.

Must provide opportunities for visitors to be introduced to nature, offerings, and the regional park and trail system.

#### Service Area

Located within a 10 min walk/ bike to areas of concentrated underrepresentation based upon Hennepin County's Population Vulnerability Composite mapping.

## Bridging PROGRAMS

#### Overview

Bridging Programs attract and increase positive use of public spaces through the delivery of introductory or specialized nature-based education programs, recreation offerings (i.e. archery programs, swimming lessons etc) and special events. Mobile bridging programs must be connected to a base regional park or park reserve.

Must provide opportunities for visitors to be introduced to nature, offerings, and the regional park and trail system. Requires reporting to measure success.

#### Service Area

Offered within a 10 min walk/ bike to areas of concentrated underrepresentation based upon Hennepin County's Population Vulnerability Composite mapping. Preferred to be held at 1st tier locations, or secondarily at off-site locations when transportation is provided (i.e. horseback riding).

## Bridging **PROJECTS**

#### Overview

Bridging Projects are individual, specialized support facilities that assist in the delivery of Bridging Programs. Examples include: programming teaching shelter, mobile programming RV that also serves as weather shelter, restoration or planting site used for education.

#### Service Area

Located within a 10 min walk/ bike to areas of concentrated underrepresentation based upon Hennepin County's Population Vulnerability Composite mapping.

If Bridging Project is mobile, such as a support RV, the investment must be used exclusively for its intended service area.

# **DEFINTIONS**

## **COMMON UNDERSTANDING for Three Rivers**

- Bridging Initiatives can be:
  - Bridging Parks | physical, stand-alone sites that are nature-based land holdings.
  - Bridging Programs | mobile recreational offerings, nature-based education and events.
    - Bridging Projects | individual, specialized support facilities that assist in the delivery of programs.
- Bridging Initiatives, in most cases, will be based on partnerships with cities, agencies, schools, non-profits, existing recreation providers or community groups.

- 16 focus groups with underrepresented community groups (incl. Black, senior, Latino/x, Asian, teen and low-income communities in partnership with 4 community liaisons and 3 organizations), 185 people engaged and counting.
- Funded through Hennepin County SHIP Grant

# ENGAGEMENT

# What we've learned from our first-tier community members from our targeted audiences:

- There is a strong interest in Three Rivers parks and programs.
- Those who are not participating in Three Rivers parks and programs are not participating because:
  - 1. They often do not have equipment that is expensive/intimidating for beginners,
  - 2. Three Rivers is not convenient to them, or
  - 3. They are unaware Three Rivers exists.

Parks to People Plan aims to fill those gaps.



# NEXT STEPS

- Summarize Community Engagement themes & how they impact recommendations.
- Assess potential Bridging Initiatives suitability based on Three River's customized 'Equity Prioritization Tool' (based upon Hennepin County Climate Vulnerability Assessment data). Conduct gap analysis when there are unidentified opportunities.
- Recommend identified Bridging Parks and create framework for Bridging Programs and supporting Bridging Projects.
- Develop Bridging Initiatives prioritization, budgets, and strategies to implement.
