2050 Regional Parks and Trails Policy Plan, Release for Public Comment

Proposed Action

That the Metropolitan Council release the 2050 Regional Parks and Trails Plan for public review and comment.

Background

This item is part of the Imagine 2050 plan and will be brought forward as part of the consolidated action with the same business item for the governing body of the Metropolitan Council. Each of the committees will review and take action on specific components of Imagine 2050.

The Metropolitan Council is nearing an important milestone in its work on the 2050 Regional Development Guide, Imagine 2050. On August 14, 2024, the Council intends to release a draft of Imagine 2050 for public comment (Table 1). Like the current Regional Development Guide, Thrive MSP 2040, Imagine 2050 will help guide the orderly growth and development of the Twin Cities metropolitan area. Imagine 2050 will include each of the Council's system and policy plans, including regional parks and trails, transportation, water resources, and housing.

At the August 1, 2024, Metropolitan Parks and Open Space Commission (MPOSC) meeting, Met Council staff will provide an overview of the public comment (90%) draft of the 2050 Regional

Parks and Trails Policy Plan, with a particular focus on new and different elements of the draft 2050 plan as compared to the existing 2040 Regional Parks Policy Plan (Attachment 1 shows a summary of changes).

The draft 2050 Regional Parks and Trails Policy Plan is the result of numerous discussions with regional park implementing agencies, the Metropolitan Council's Committee of the Whole, Community Development Committee, and MPOSC, as well as extensive outreach to prioritized communities. Engagement with MPOSC on the 2050 Regional Development Guide began in August 2022, with a focus on regional values, vision, and goals, and has continued since.

As part of the planned integration of the policy plan into Imagine 2050, Met Council staff have reviewed draft content to ensure it is fundamentally oriented to objectives, policies, and actions. Content that is contextual, procedural, or includes more detailed requirements is proposed to be moved into the Regional Parks and Trails Planning Handbook. Council staff shared an overview of the draft planning handbook with MPOSC at the June meeting. Staff will return to MPOSC with an update on the draft planning handbook this fall.

Following the public comment period, scheduled to end on October 7, 2024, Council staff will prepare public comment reports and refine draft policy plan content as appropriate. The Regional Development Guide is proposed for adoption on February 12, 2025.

As noted, MPOSC engagement on the 2050 Regional Development Guide began in August 2022, with focused discussions on updating the Regional Parks Policy Plan beginning in October 2022. Council staff sought the advice of MPOSC and shared the advice of regional park implementing agencies, other Council committees, and other stakeholders in each of these engagements. A summary of the engagement appears in Table 2.

Minnesota law requires the Council to conduct a comprehensive review of the Regional Parks Policy Plan at least every four years (Minnesota Statutes, section 473.147). Completion of the policy plan update, as an integrated part of *Imagine 2050*, is expected in early 2025.

Summary of Changes

Added the following 12 items to the 2025-2028 workplan:

- 1. Develop process to create a small set of indicators at the Objective level to measure progress toward our key Regional Park and Trail System priorities.
- 2. Explore establishment of a Special feature Historical landscape sub-classification
- 3. Explore establishment of a Special feature Open space/natural systems subclassification
- 4. Convene regional park implementing agencies to develop cultural resources inventory requirement for long-range planning. Continue to engage American Indian Tribes and communities for advice and direction.
- Continue to convene a trail coordination workgroup, supporting the development of a more coordinated, integrated, and connected regional trails system and Regional Bicycle Transportation Network.
- 6. Create regional guidelines for e-bike use on regional trails.
- 7. Explore system-wide wayfinding and signage minimum requirements.
- 8. Explore establishment of system-wide Asset Preservation Plan.
- 9. Continue to pursue Pay-Go for greater flexibility to fund a wider range of activities and programs.
- 10. Explore changing/reducing the local match requirement for the Park Acquisition Opportunity Fund Program, as state rules allow.
- 11. Continue discussion of strategic funding for the Regional Parks and Trails System.
- 12. Implement the 2025 Regional Parks and Trails System Visitor Study.
