Proposed Action

That the Metropolitan Parks and Open Space Commission schedule their April 2, 2013 meeting under the following agenda:

3:00 p.m. meet at Gale Woods Farm Special Recreation Feature

3:15 p.m. to 4:30 p.m. tour Camp Kingswood proposed as a Special Recreation Feature

4:30 p.m. to 6:00 p.m. business meeting at Gale Woods Farm Special Recreation Feature

Background

At the February 5th Metropolitan Parks and Open Space Commission (MPOSC) meeting, the Commission considered a request by Three Rivers Park District to amend the *2030 Regional Parks Policy Plan* by adding a 106 acre parcel (Camp Kingswood) as a Special Recreation Feature. The MPOSC recommended that a public hearing be held on this request by the Community Development Committee of the Metropolitan Council at its April 15th meeting. The Community Development Committee concurred on that recommended action at its February 19th meeting.

Three Rivers Park District has extended an invitation to MPOSC members, Metro Council members and Council staff to tour the Camp Kingswood site prior to the April 2nd MPOSC business meeting. (See **Attachment 1: Letter from Jonathan Vlaming, Three Rivers Park District**)

Rationale

This tour provides an opportunity for MPOSC members and Metro Council members to see the site first hand and to get an overview of the acquisition master plan for the site. The MPOSC can also conduct its April business meeting at nearby Gale Woods Farm Special Recreation Feature.

Funding

As noted at the February MPOSC meeting, if the Metropolitan Council amends the 2030 Regional Parks Policy Plan to add the Camp Kingswood site as a Special Recreation Feature, and the Council approves an acquisition master plan for the site, the Park District

will request a Park Acquisition Opportunity Fund grant to partially finance the acquisition of the site.

Known Support / Opposition

Touring the Camp Kingswood site is appropriate in the MPOSC and Metro Council consideration of designating the site a Special Recreation Feature as an amendment to the 2030 Regional Parks Policy Plan. There is no known opposition to the request.
