

Metropolitan Council Transportation Funding Forecast State Fiscal Years 2018-2019









State FY 2018-2019 Forecast

- \$1.4B surplus expected for next biennium
- Slower economic growth
- Lower revenue projections were offset at the state level by reduced spending estimates
- Motor Vehicle Sales Tax (MVST) projections further reduced from February forecast

Motor Vehicle Sales Tax

- MVST expected to make up 44% (\$225M) of our overall 2016 transit operating budget of \$517M
 - Budget 95% of state forecast
 - Receipts above 95% go to MVST reserve for next year's operations
 - Currently calendar year 2016 at 95% of forecast used when adopting 2016 budget. Hence, no carry over MVST into 2017.
 - Each 1% = \$3M in MVST receipts





CY 2017 Council Budget Impact

- November 2016 Forecast
 - \$8.9M reduction in MVST operating revenues
- Experience (95% of November 2015 Forecast)
 - \$2.7M reduction in MVST reserve transfer
- Draw on Regional Transit Reserves

Preferred Solution

Governor's transit sales tax proposal (2013-2016)

- Recognizes instability of MVST revenues
- Creates stable, long-term funding that allows us to effectively plan and budget transit investments
- Eliminates entire deficit
- Funds needed transit growth to accommodate job growth and workforce demands
- Enhances equity and geographic balance throughout the region







Immediate Administrative Actions

- Targeted, temporary hiring freeze
- Reductions in administrative costs
- Review of planned 2017 projects







Under Consideration

Absent the Governor's sales tax proposal, some options are under consideration in order to balance the Council's transportation budget.

- Fare increase
- Service reductions
- Medical Assistance revenues for eligible Metro Mobility services







Timing Considerations

- Public engagement must start soon.
- Early 2017 Council discussion of proposals needed prior to public comment and engagement.
