**SUBJECT:** 2013-2016 TIP Amendment for Wayside Rest at the Rock Island River Pier project on the Great River Road (TH56) in Dakota County

**REQUESTED ACTION:** Dakota County requests a TIP amendment to add the Wayside Rest at the Rock Island River Pier project on the Great River Road (TH56) using National Scenic Byways federal funds (SP#019-060-010).

**RECOMMENDED MOTION:** Recommend that the Transportation Advisory Board adopt an amendment to the 2013-2016 Transportation Improvement Program (TIP) to add SP#019-060-010, the Wayside Rest at the Rock Island River Pier on the Great River Road with \$450,000 of National Scenic Byways funding and \$430,000 in county funding for a total cost of \$880,000 in 2013.

**BACKGROUND AND PURPOSE OF ACTION:** Dakota County received federal National Scenic Byways funding for this project in fall of 2012. The wayside rest will be located on the Great River Road (TH56) at the Rock Island River Pier on the west bank of the Mississippi River at 66<sup>th</sup> Street in Inver Grove Heights. The project will construct a four-season restroom, picnic shelter, parking for motor vehicles and bicycles, and trail connections to the national Mississippi River Trail.

**RELATIONSHIP TO REGIONAL POLICY:** Federal law requires that all transportation projects that will be partially funded with federal funds must be in an approved TIP and meet the following four tests: fiscal constraint; consistency with the adopted regional transportation plan; air quality conformity; and opportunity for public input. It is the TAB's responsibility to adopt and amend the TIP according to these four requirements.

**STAFF ANALYSIS:** The TIP amendment meets fiscal constraint because the funds are new to the TIP through a new \$450,000 grant from the National Scenic Byways Program and \$430,000 of county funding. The amendment is consistent with the Transportation Policy Plan, adopted by the Metropolitan Council on November 10, 2010, with FHWA/FTA conformity determination established on February 23, 2011. The project is exempt from regional air quality analysis, and public input opportunities are provided through the TAB's and Council's regular meetings.

**COMMITTEE COMMENTS AND ACTION:** At its February 6, 2013, meeting, the TAC unanimously approved a motion to recommend this TIP amendment to the TAB for adoption.

**PROJECT BACKGROUND:**

1. Briefly describe why amendment is needed (e.g., project in previous TIP but not completed; illustrative project and funds now available; discretionary funds received; inadvertently not included in TIP).

An amendment is needed for this project, SP019-060-001, to add the project to SFY 2013 of the TIP. This project was awarded a \$450,000 National Scenic Byways program (NSBP) federal grant in August 2, 2012. This was after the TIP was developed so it was not included in the 2013-2016 STIP.

The National Scenic Byway-Great River Road, designated by the FHA and U.S. Secretary of Transportation, runs adjacent to the Mississippi from Minnesota to Louisiana. This project site is along TH 56 at the Rock Island River Pier on the west bank of the Mississippi River at 66<sup>th</sup> Street in Inver Grove Heights.

The project will be the construction of a four-season restroom, an outdoor picnic shelter, motor vehicle and bicycle parking for the wayside, bituminous trail connections to the national Mississippi River Trail, driveway improvements, wayfinding on the site, orientation and interpretive information, and monument signage to direct motorists and bicyclists to the wayside. The site will be ADA accessible allowing people with limited mobility opportunities to get close to the river.

\*These federal funds are newly released grant funds from National Scenic Byways Program (NSBP) through enactment of the Surface Transportation Extension Act of 2012, Part II. This project was awarded \$450,000 and has a total project cost of \$880,000 including the \$450,000 grant from the NSBP and \$430,000 match from Dakota County. These funds are sufficient to fully fund this project, therefore fiscal constraint is maintained.
