description of MnDOT's I-35W pavement resurface and

rehabilitation project (SP# 6284-166).

BACKGROUND AND PURPOSE OF ACTION: This amendment is needed to amend the scope and description of a mill and overlay on I-35W from County Rd C in Roseville to I-694 in Arden Hills. The amendment will remove "guardrail and signing" from the project description, as these components have been removed from the project. The amendment will also add traffic management systems (TMS), which was also left out of the most recent TIP update.

RELATIONSHIP TO REGIONAL POLICY: Federal law requires that all transportation projects that will be funded with federal funds must be in an approved TIP and meet the following four tests: fiscal constraint; consistency with the adopted regional transportation plan; air quality conformity; and opportunity for public input. It is the TAB's responsibility to adopt and amend the TIP according to these four requirements.

STAFF ANALYSIS: The TIP amendment meets fiscal constraint because the state and federal funds are sufficient to fully fund the project. The amendment is consistent with the Transportation Policy Plan, adopted by the Metropolitan Council on January 14, 2015, with FHWA/FTA conformity determination established on March 13, 2015. The Minnesota Interagency Air Quality and Transportation Planning Committee determined that the project is exempt from air quality conformity analysis. Public input opportunity for this amendment is provided through the TAB's and Council's regular meetings. This amendment meets the criteria for using the TAB's streamlined TIP amendment process and was recommended for streamlining by the TAC Executive Committee.

PROJECT BACKGROUND:

This amendment is needed to amend the scope and description of a project in the TIP. The project is a mill and overlay on I-35W from County Rd C in Roseville to I-694 in Arden Hills. It also includes work to drainage, striping, and traffic management systems (TMS). The amendment will remove "guardrail and signing" from the project description, as these components were removed from the project in the last year, but were not updated in the most recent TIP update. The amendment will also add the language "TMS", referring to transportation management systems, which was also left out of the most recent TIP update.
