Performance Based Planning

- Federal law requires MPOs to tie the selection of transportation investments to outcomes and measure progress towards meeting the desired outcomes (performance-based planning)
- Current plan sets Transportation System Goals, Objectives, Strategies
- A key component of performance based planning is identifying the important measures that will help the region select investments
- Selected performance measures and targets included in plan update
- Ability to describe impact of the plan

Federal Performance Measures – Effective Date

- Measures cover several areas:
 - Safety
 - Transit State of Good Repair
 - Pavement Condition
 - Bridge Condition
 - System Performance
 - Freight
 - CMAQ
- Safety and State of Good Repair have been issued
- Remaining 5 have been postponed until May 20th, 2017

Federal Performance Measures -Targets

- MnDOT required to set state targets within 1 year of federal measure effective date
 - 4 year cycle
 - 2 and 4 year targets
 - 4 year target may be adjusted at 2 year mid-point
 - New 2 and 4 year targets set at end of first 4 year cycle
- MPOs required to set state targets within 180 days after state DOT sets targets
 - May adopt specific targets
 - May elect to support state targets
 - May set longer term targets, but they will have no federal reporting requirements except as part of LRTP

Regional Performance Measures

- 2040 TPP included performance measures of more regional relevance to evaluate the TPP's impacts on:
 - Plan goals
 - Plan objectives
- Refinement of measures reported in Chapter 12 of the 2040 TPP has been underway over the previous year
- TAC Planning Committee serves as PMT
- Beginning to evaluate data to set targets for plan performance measures



| Transit | Job and Population Growth near High Frequency Transit Service | Local | Yes |
| | Transit Supportive Comprehensive Plans | Local | Yes |

- Establish MPO targets for federally required measures.
- Develop local targets for non-federal measures as needed.
