2017-29: Measures & Scoring Guidance

- Service & Customer Improvements (Transit Modernization): Staff adjusted language so travel time savings is called out as key element. (page 116)
- TAC recommends 50-point “snow and ice control” measure that requires inclusion of maintenance plan.

2017-30: Weighting of Criteria and Measures

TAC recommends attached weighting of criteria and measures.

2017-31: Functional Classification

TAC recommends continuing the practice of funding at least one roadway project from each functional classification.

2017-32: Modal Ranges

Modal ranges shown below reflect historic distribution since 2003. Roughly \$200M assumed available for 2022 and 2023.

TAC recommends using these historic ranges.

2017-33: Policies, Qualifying Criteria, and Eligibility

- TAC recommends including requirement for substantial work toward ADA transition plan.

TAC recommends the above minimum and maximum federal amounts.

2017-35: Project Inflation Adjustment and Year of Estimate

TAC recommends not using an inflation adjustment and asking for cost estimates be in current year (i.e., 2018) dollars.

2017-36: Release Solicitation for Public Comment

TAC recommends releasing the 2018 Regional Solicitation for public comment, inclusive of recommended changes in the previous items.

Public comment period: Nov 20-Dec 8.

Final TAB approval of application: Jan 17.
