I. CALL TO ORDER

A quorum being present, Chair Hovland called the regular meeting of the Transportation Advisory Board to order at 12:33 p.m. on Wednesday, March 17, 2021.

III. REPORTS

1. TAB Chair's Report

Hovland reported on the new TAB alternates. Hovland shared the need for county commissioners on the unique projects working group.

2. Agency Reports MnDOT, MPCA, MAC, and Metropolitan Council

MnDOT, Mike Barnes:

Barnes reported on the federal COVID relief funding, that guidance is still being put together. MnDOT is applying for an INFRA grant. BUILD grants will be up for notice in the next month. Construction is getting closer and it's the final year for a couple of projects. Narayanan added that MnDOT has adopted the recommendations from the STAC.

MPCA, Todd Biewen:

Biewen reported that the Clean Cars Minnesota rulemaking public comment period closed. Hollinshead asked how much of the VW settlement money will go toward charging stations.

MAC, Carl Crimmins:

Crimmins was absent but sent a report that TAB Coordinator Koutsoukos read:

Barber reported on the next arterial BRT lines. Barber shared that transit operators are beginning to receive vaccines.

Solberg reported that the TAAC has gotten updates on the statewide multimodal transportation plan.

V. INFORMATION

1. Regional Solicitation Feedback and Preparation

Metropolitan Transportation Services Senior Planner Joe Barbeau presented this item.

McGuire asked for more information on bike and ped impact. Barbeau said bike/ped bridges were applied for in multiple categories. Sanger asked if different ways of measuring roadway equity could be explored. Geisler asked about minimum and maximum funding amounts and if they're on the list to be looked at. Barbeau said it can be examined.

2. Equity – Rethinking Areas of Concentrated Poverty

Metropolitan Transportation Services Senior Planner Heid Schallberg presented this item.

Hollinshead commented about buy-in happens with white people who have experienced economic hardship. Udermann brought up other perspectives that people of color may have themselves. Biewen asked for data on generational differences regarding reparative approaches. Sanger mentioned bureaucratic policies. Goetz said it will likely take years of analysis and the actions of planners to turn the rulemaking. Narayanan brought up the differences between discussing advantages and disadvantages. Goettel said being outside of housing policy will hopefully make it more encompassing.
