## **Metropolitan Airports Commission** (MAC) Roles



### Minnesota Statutes 473.601-473.679

- Promote aviation & competitive air service
- Owns & operates seven public airports in metro area
- Prepares airport long-term comprehensive plans
- Annually prepares capital improvement program (CIP) to implement planned improvements
  - Annually prepare an environmental assessment of CIP projects (Assessment of Environmental Effects (AOEE))

## Met Council Aviation Planning Roles



### Minnesota Statutes 473.146 & 473.621

- Prepare Regional Aviation System Plan
- Review metro airport & community ulletcomprehensive plans, environmental evaluations
- **Review MAC's Capital Improvement Program** ulletand review and approve major capital projects that have a significant affect on the orderly and economic development of the region
  - TAC/TAB review/comment on draft CIP
  - Final CIP adopted by MAC reviewed by • **Transportation Committee and Council**
  - Any shifted projects reported to TAC/TAB

# MAC Capital Projects Review (1)



### **Capital Projects Review Criteria**

- Projects over \$5 million at MSP and over \$2 million at • reliever airports that have potential for significant effects
- Significant effects criteria
  - Location of a new airport
  - New runway at an existing airport
  - Runway extension at an existing airport
  - Runway strengthening other than routine maintenance
  - New or expanded passenger handling or parking facilities for 25% or more capacity increase
  - Land acquisition associated with the other criteria, or that would cause relocation of residential or business activities

# MAC Capital Projects Review (2)



### **2024 Capital Projects Review**

- Adequate public participation process
- Assessment of Environmental Effects (AOEE) completed and reviewed
- MAC's CIP identifies adequate funding  $\bullet$
- MAC's CIP is consistent with the 2040 TPP
- Many large projects planned for 2024 at MSP
- There is one capital project identified for construction in 2024 that would require Met Council approval\*



## **Big year planned for 2024 - \$1 billion in new projects**

Major MSP Projects in 2024 – no requirement for Met Council approval but notable projects

- Terminal 2 North Gate Expansion
- **Concourse G Infill**
- Safety and Security Center
- **Terminal 1 Concourse Modernization**

Rendering of the Terminal 2 expansion





## MAC Capital Projects Review (5)

## Lake Elmo Airport (21D) Runway 04-22\*

- Pavement rehabilitation and runway extension
  - Crosswind runway will be extended by 254' to 2,750'
- Included in 2016 Long Term Comprehensive Plan
  - Main runway extension (14-32) approved in 2018
  - Final planned runway project (runway 14-32 constructed in 2021)
- Included in 2018 EA/EAW
  - No significant environmental impact
- Consistent with Transportation Policy Plan
  - Lake Elmo is classified as a Minor Airport in the regional system, existing role will not change.

\*Shifted back to 2025 in adopted CIP – project will be formally reviewed for approval by Council in 2024/25



## MAC CIP Looking Forward

### **2025-2030 Capital Investments**

- 2024 will be a big year for MAC, over \$1 billion capital program planned
  - MSP projects expected to continue to be above \$500 million through 2027
- 2025 will likely have a project for Met Council approval next year, runway expansion at Airlake in Lakeville and previous Lake Elmo project
- MSP and Flying Cloud Long-Term Comprehensive Plans anticipated to be completed in 2024
  - May see projects from these plans be incorporated beginning in next year's CIP for later years.
