#### **Requested Action**

The City of Bloomington requests an amendment to the 2025-2028 Transportation Improvement Program (TIP) to add a multi-use trail and intersection improvements to its CSAH 34 (Normandale Blvd) sidewalk, curb ramp, and signal project.

#### **Recommended Motion**

That the Transportation Advisory Board recommend approval of an amendment to the 2025-2028 Transportation Improvement Program to add a multi-use trail and intersection improvements to the City of Bloomington's CSAH 34 (Normandale Blvd) sidewalk, curb ramp, and signal project.

### **Background and Purpose**

The City of Bloomington was awarded \$2,000,000 in the 2024 Regional Solicitation for its CSAH 34 (Normandale Blvd) sidewalk project. The project includes ADA curb ramps, traffic signals, and retaining walls. The project was amended into the 2025-2028 TIP on December 11, 2024.

This request involves the addition of locally funded, locally sponsored trail and intersection improvements adjacent to the project. This is an administrative modification.

### **Relationship to Regional Policy**

Federal law requires that all TIP amendments meet the following tests: fiscal constraint; consistency with the adopted regional transportation plan; and opportunity for public input. It is the TAB's responsibility to recommend TIP amendments to the Council for adoption, provided these requirements are met.

### **Staff Analysis**

The TIP amendment meets fiscal constraint because the federal and local funds are sufficient to fully fund the project. This amendment is consistent with the Metropolitan Council Transportation Policy Plan, adopted by the Metropolitan Council on February 12, 2025. Public input opportunity for this amendment is provided through the TAB's and the Council's regular meetings.

## **Committee Comments and Action**

At its April 2, 2025, meeting, the Technical Advisory Committee recommended approval of an amendment to the 2025-2028 Transportation Improvement Program (TIP) to add a multi-use trail and intersection improvements to Bloomington's CSAH 34 sidewalk, curb ramp, and signal project.



Additional work is local funded, therefore fiscal constraint is maintained.



Short write up with reason for scope change (i.e.; contractor coordination, better bids, etc.):

The trails and sidewalks on both sides of Normandale Blvd along with associated intersection improvements from 94<sup>th</sup> St to Old Shakopee Rd (CSAH 1) will be completed in one large project to avoid multiple, separate project impacts to adjacent residents and the traveling public. This will also allow for a better economy of scale for bid prices, since a large amount of the work type is similar in nature.

The additional work will be funded with local and State Aid funds






