BACKGROUND AND PURPOSE OF ACTION: Federal regulations require that a Transportation Improvement Program (TIP) be developed at least every four years. The Metropolitan Council revises its TIP every year in conjunction with the Minnesota Department of Transportation's State Transportation Improvement Program (STIP). The attached schedule includes the major dates in the development process for the 2015-2018 TIP. This schedule differs from previous years in that the draft TIP will be presented beginning at the Funding and Programming Committee in May instead of April. After the public comment period, the comments and final TIP will be taken back to TAB directly, consistent with other Council processes. This change in process allows additional time for the draft development in April and eliminates a conflict with MnDOT STIP development schedules and Council committee schedules in April. The public input process is under discussion and the format of it may change, but any changes to it would not affect the TIP development schedule.

**RELATIONSHIP TO REGIONAL POLICY:** Federal law requires that all transportation projects that will be partially funded with federal funds must be in an approved TIP.
