- STIP usually approved by FHWA in fall

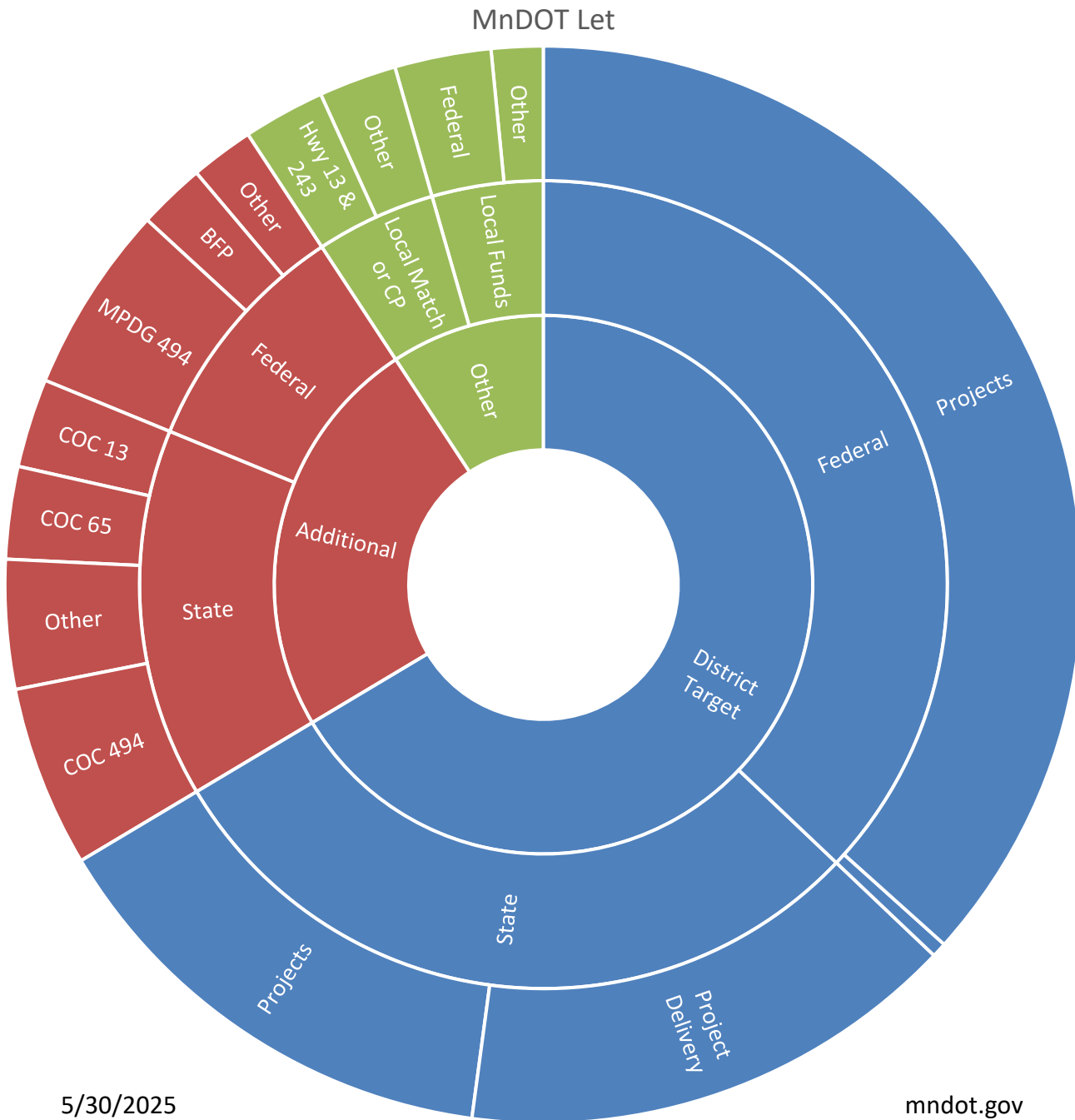
# ATIP by the numbers

- US 8 (LAKE BLVD), FROM I35 TO CHISAGO COUNTY LINE IN FOREST LAKE - RECONSTRUCT
- MN 243 (OSCEOLA), OVER ST CROIX RIVER IN FRANCONIA TWP- REPLACE BRIDGE #6347
- MN 77 (CEDAR), FROM 138TH ST (HWY 23) TO DAKOTA/HENNEPIN COUNTY LINE IN APPLE VALLEY – UBOL
- US 12 (WAYZATA BLVD), FROM 0.5 MI W SHORELINE DR IN WAYZATA TO 0.5 MI E OF I494 IN WAYZATA AND MINNETONKA – RECON AND M&O

- MN 100, FROM UNDER PED BRIDGE/EXIT CEDAR LK RD IN ST LOUIS PARK TO JCT I694 IN BROOKLYN CENTER – PAVEMENT REHAB
