SUBJECT: TAC – Aviation Task Force 2013 Membership Certification
MOTION: That the Transportation Advisory Committee approve the attached 2013 membership roster for the TAC- Aviation Advisory Task Force.

BACKGROUND AND PURPOSE OF ACTION: TAC bylaws specify that the TAC Chairperson may establish task forces and develop their charge subject to approval by the Executive Committee. Activities shall be reported to the TAC at regular meetings and the results are subject to approval by the TAC membership. The membership and purpose statement of each task force shall be approved by the TAC annually.

TAC Aviation Task Force and membership needs to be approved at this time so the group can assist with the Council's annual review of the MAC CIP. This task force also reviews and provides guidance to the Metropolitan Council in the annual review of the MAC CIP.
