BACKGROUND AND PURPOSE OF ACTION: On Wednesday, June 19, 2013 the Transportation Advisory Board held a public hearing on the draft 2014-2017 Transportation Improvement Program for the Twin Cities Metropolitan Area. Comments were also collected over a 45-day public comment period in accordance with Council policy for public hearings.

The public hearing and public comment period affords the public an opportunity to see the draft TIP and to understand how it is prepared, the amounts and sources of funding, which agencies program funds in the TIP and how they determine which projects to fund. The public can comment on any aspect of the draft TIP and staff will prepare a response for the public record. Project sponsors may also comment on their projects in the draft TIP. The attached public comment report documents the public involvement during the development of the TIP.

RELATIONSHIP TO REGIONAL POLICY: Preparation, adoption and maintenance of the region's Transportation Improvement Program is one of the TAB's main responsibilities. The TAB has the lead role in this important effort because the Board membership includes local elected officials. Reasonable opportunity for public comment and input during the preparation of the TIP is required by federal law. The public comment report documents the TAB's public input efforts during the preparation of the 2014-2017 TIP.

STAFF ANALYSIS: Staff has provided responses or recommendations to all of the public comments received during the public hearing and submitted outside the public hearing during the public comment process. Staff analysis is included in the public hearing report and the public comment report.

Transportation Advisory Board Chair William Hargis called the public hearing on the DRAFT 2014-2017 Transportation Improvement Program (TIP) for the Twin Cities Metropolitan Area to order at 3:00 pm, June 19, 2013, Metropolitan Council Chambers, 390 North Robert St., St. Paul. Chair Hargis invited members of the public to provide comments and ask questions.

Ryan Gaug presented information on the amount of federal and state funds that are allocated statewide by MnDOT and the investment philosophy that guides the allocation. Mr. Gaug described the Metro District transportation investments by program for fiscal year 2017, the first year affected by the Metro District investment outcomes for all four years of the TIP and highlighted major projects in the Program.

Kevin Roggenbuck described how the TIP is developed and which organizations program transportation funds in the TIP. Mr. Roggenbuck also described how the TIP is prepared and adopted, including the public involvement process, and finally approved by the US Department of Transportation.

Amy Vennewitz presented information on the amount of federal funds that are allocated toward transit projects in the metro area by the Metropolitan Council. Ms. Vennewitz described the different federal sources of funds and described the council's capital planning process. Ms. Vennewitz highlighted several major transit projects programmed in the TIP, including federal New Starts funding for the Southwest light rail transit line.

June 19, 2013

Comments and Questions from the public in attendance:

Kathleen Murphy, Transit for Livable Communities, expected that the Southwest light rail transit line would start in 2014 and commented on the delay in funding and implementation of the Southwest light rail transit line. Transit for Livable Communities has been lobbying the Governor's office and legislators to begin construction in 2014 but without success.

Ms. Vennewitz responded: Met Council is working with the federal government, currently in Preliminary Engineering, and is fully funded with local funds, the project is not delayed. What you see in the TIP is when the Council first expects to receive federal funds. Once the Council gets approval to enter the construction phase, the federal government will commit funding and be received in 2016.

Heidi Schallberg described what the TIP is and explained the four federal requirements that must be met in preparing the TIP and the schedule for adoption and approval. Ms. Schallberg described the percentage of federal funds and total funds that are programmed in the TIP by the Metropolitan Council, Minnesota Department of Transportation and the TAB.

Shosh Dworsky, resident of St. Paul: Said she is excited about bus service between the MSP Airport and the Apple Valley transit center and asked whether it would help get her to work in Northfield.

Ms. Schallberg responded: The Cedar Avenue bus rapid transit line will serve Apple Valley and is scheduled to open on June 22, but also asked for her contact information to more directly answer her question.

Kris Radford, KMR Design Group: Encouraged de-bundling of work on large transportation projects for small women and minority landscape businesses.

Mr. Hargis responded: MnDOT and Council staff has heard you and will pass that comment along to those developing large transportation projects.

Those present were reminded of the public comment period and encouraged to submit their comments as directed on the Metro Council website.

ADJOURNMENT

Hargis adjourned the public hearing on the DRAFT 2014-2017 Transportation Improvement Program for the Twin Cities Metropolitan Area at 3:45 pm on Wednesday, June 19, 2013.

The Minnesota Department of Transportation (MnDOT) has worked closely with the staff of the Metropolitan Council and the Transportation Advisory Board (TAB) and the Technical Advisory Committee (TAC) in development of the draft 2014-2017 Transportation Improvement Program (TIP). As part of our normal process, several minor changes have occurred since that time, including end-of-year changes affecting a number of individual projects.

The attached tables identify the individual proposed changes to the draft 2014-2017 TIP. These changes are, for the most part, end of fiscal year balancing changes, and projects shifting among years of the TIP along with any additions or deletions. In addition to changes in these tables, some changes have been made to "Advance Construction" and "Advance Construction" paybacks due to projects moving between years of the TIP, and actual project letting costs have been updated.

With the proposed changes, we believe that the TIP remains fiscally balanced in the first two years, and generally balanced in the remaining years. These proposed changes do not affect the air quality conformity analysis of the TIP, as we have discussed with staff of the Minnesota Pollution Control Agency and the Metropolitan Council.

Thank you for the opportunity to comment on the 2014-2017 TIP for the Twin Cities area by providing these proposed changes.

Here are Hennepin County Transportation comments on the Draft 2014 - 2017 TIP. One project (CSAH 53 – 027-653-021) has a minor description correction to make it consistent with the approved project application description. All the projects CSAH 5 (027-605-029), CSAH 61 (027-661-046), CSAH 53 (027-653-021) and CSAH 81 (027-681-034) CSAH 135 (027-735-003) have cost changes due to refinements in estimating the project cost, not changes in project scope. The bridge project estimate for CSAH 135 (027-735-003) is for bridge construction only and excludes R/W and related work beyond the abutments such as roadway approaches. The total change in project costs do not trigger the need for a TIP/STIP amendment based on FHWA and MnDOT guidance for STIP amendments and administrative modifications. Changes are shown in *BOLD*. All additional costs are shown as non-federal. Please accept these construction estimate changes pending review by staff as to how they might affect the project's ranking in the regional solicitation.

Dear Mr. Roggenbuck:

Thank you for the opportunity to review the 2014 -2017 TIP and to make comments on the program as a whole. Surface transportation policies at the regional and state levels have a direct impact on the quality of life that our residents enjoy, as well as direct impacts to the growth and economic vitality of Anoka County. Your report states that 60 percent of new households and 45 percent of new employment opportunities will be in developing areas, which describes much of Anoka County. However, with this new growth come new challenges. Our transportation systems are being asked to carry more traffic and we, along with our local communities, are asked to convey more of the burden of transportation funding for routes that have major state and regional significance.

With this being said, it is concerning that when a resident of the metro region who resides in Anoka County looks at this plan he will see that significant inequalities are apparent. The lack of major projects in Anoka County is concerning. But for the STP and HSIP projects that Anoka County has directly competed for and garnered, there is a complete absence of projects in Anoka County. Unless we are reading this document incorrectly, how can it be that Anoka County will receive only one minor project in the NHPP program, and no projects in the CMAQ and TAP funding categories? These three programs represent over \$1 billion in investments for the metropolitan area but practically none of it is being spent in Anoka County. Anoka County represents 14.4% (2,364 miles) of the roadway miles in the 7-county metro area and carries 11.2% (8.2 million daily VMT) of the traffic volume. While the funding splits of the STP (8.78%) and HSIP (5.21%) are somewhat reflective of an equitable regional split, the lack of funding through the other programs is very disturbing.

It is our hope therefore, that as the region implements the new MAP-21 legislation and sets regional priorities, it continues to allow a fair and robust competition for these funds, and for those funds that a solely at the discretion of MnDOT, TAB or the Metropolitan Council, that a fair and equitable distribution is made across the entire metro area including Anoka County.

Again, thank you for the opportunity to comment on the draft 2014-2017 TIP. If you have any questions or need additional information, please feel free to let me know.

The purpose of this letter is to provide Scott County comment on the proposed 2014 - 2017 Transportation Improvement Program (TIP). The County has reviewed the TIP in relation to our own planning and budget. The County provides the following comments:

- 1. Scott County has programmed Highway Safety Improvement Project (HSIP) SP 070-602-020 (roundabout at CSAH 2 and CSAH 46) for construction in 2014 to coincide with a 2014 Dakota County project (SP 019-609-018). Scott County requests the HSIP funding to be advanced from 2015 to 2014. If it is not possible to move the funds to 2014, the County requests to Advance Construct this HSIP project in 2014. We request this change is reflected in the final TIP.
- 2. In the description for project 7005-106, under 100% State Funded Project in 2016, the eastern project limit should be revised to CSAH 21 instead of CSAH 18. The County redesignated a portion of CSAH 18 as CSAH 21 when a new segment of CSAH 21 opened to traffic in 2011.

To Whom It May Concern:

I am writing in response to the Metropolitan Council's request for comments on the Regional 2030 Transportation Policy Plan. My comments are specific to the I-494 Third Lane Addition (referred to as S.P. 2785-330 by MnDOT) project included in the plan. This project is very important to Plymouth, the community that I represent as mayor.

The Project in Historical Context

Because I-494 goes from three to two lanes through Plymouth, causing bottleneck congestion, adding a third lane has been a priority of the Plymouth City Council for many years. Beginning in 2005, former Council Member Sandy Hewitt and staff represented the City of Plymouth on various working committees that were charged with developing a plan to add a third lane on I-494 from TH 55 to Fish Lake Road in Maple Grove.

As the planning of that project progressed, so did the magnitude of the improvements. In 2006, the debate had evolved to whether the improvements to I-494 should include three lanes in each direction or four. As the project scope grew, so did the price tag. The estimated cost was about \$245 million. MnDOT ultimately determined that a project of this magnitude was unaffordable. Consequently, the project was shelved.

In late 2008, MnDOT advised the City of Plymouth that it was developing a smaller scale, low cost/high impact improvement for I-494 in Plymouth (see attached Project Summary).

On February 17, 2009, city staff members and I met with MnDOT representatives to discuss the specifics of their proposal. It was a project that MnDOT was enthusiastic about. We were encouraged to hear that the proposal, which had a dramatically lower cost of \$43 million, would yield exceptionally high returns in terms of easing congestion. We were also pleased to hear that the project could be shovel-ready for additional stimulus funding as soon as 2012.



In January 2010, MnDOT staff met with city staff and me. We learned that MnDOT had changed course. Instead of the \$43 million project presented in February 2009, MnDOT and the Metropolitan Council were considering the I-494 lane addition as a strong candidate for a "managed lane." This came as a surprise to us given the historical context provided above.

We subsequently met with area appointed and elected officials as well as staff from the Metropolitan Council and MnDOT to discuss the managed lane concept. During that meeting it became clear that whether a managed lane made sense for this stretch of I-494 was secondary to getting a jump start on a managed lane system for the metro as a whole. At this meeting we heard statements like, "We will never have a managed lane system if we don't start now" as the reasoning behind this proposal. We were advised by MnDOT not to make up our mind about the managed lane until further analysis was done.

Comments on Proposed I-494 Managed Lane

It is with this historical context as a backdrop that I offer the following comments on your plan:

- Page 93, Table 6-32: "Lower-Cost/High-Benefit Projects Recently Completed/Under Development" fails to include the \$43 million option proposed by MnDOT in 2009 despite its findings that the project has an extremely high benefit/cost ratio.
- Page 96, Figure 6-34: "Managed Lane System Vision" identifies the interchange of I-494 and I-394, a managed corridor already in place, as "Through Movement Only" rather than "Direct Connection." This seems to contradict the statement on page 98 of your plan that "...opportunities for new managed lanes will be sought with the objective to grow and builds upon and connects to managed corridors already in place..."
- Page 97, Table 6-35: "Managed Lane Vision Projects" identifies Corridor I-494 A as adding a left MnPASS lane at a cost of \$61 million. It seems that this conclusion has been arrived at despite there being no additional analysis that I am aware of
- Page 99, Table 6-36: "Expansion Projects Reassessed" and Page 100, Figure 6-37: "Expansion Projects to be Reassessed" identify the previous \$245 million project on I-494 as an expansion project that should be reassessed. Both are silent to the \$43 million option proposed by MnDOT in 2009 despite its findings that it has an extremely high benefit/cost ratio. This conflicts with page 101 of the plan, which state, "Particular emphasis has been placed in the reassessment process to identify lower-cost/high-benefit improvements."
- Page 102, Table 6-38: "TPP Major Project Funding Recommendations" identifies the I-494 managed lane project as funded in the 2021-2030 timeframe, provided the funding scenario in Table 6-29 is achieved. This funding scenario assumes supplemental funding in addition to formula funds. The timing and funding uncertainty is disconcerting given the history of this project as identified above.

In conclusion, in 2010 the Plymouth City Council adopted the following goal:

"Promote Transportation Solutions. Advance transportation and transit solutions to improve the local economy, promote business growth and development, and improve area roadways and highways to reduce commuter congestion. Focus on maintaining suburban transit and advancing the following projects: third lane on I-494, study of Highway 169 between I-494 and I-94, and improvements to Highway 55."

This has long been a goal of ours, and we will continue to strive to achieve it. We believe that greater consideration should be given to the lower cost option proposed by MnDOT in 2009 and that consideration be given to advancing that project so that construction can begin as soon as possible.

Based on MnDOT's own assessment, this is a lower cost/extremely high benefit project that would ease congestion sooner rather than later. It would also not treat this relatively short segment of I-494 in Plymouth differently than it has been treated on either side of our community.

Thank you for your consideration of our comments. We encourage you to reassess instituting the concept of a managed lane "mid-stream" on I-494 in Plymouth, and instead look for areas where it will better integrate with the existing freeway system.

The Transportation Advisory Board held a 45-day public comment period on the draft 2014-2017 Transportation Improvement Program, beginning on May 15 and ending on June 28, 2013. All comments received at the public hearing held on June 19, 2013 are included in the public hearing report and all written comments received by the close of the public comment period are attached to this memo. Below is a summary of the comments received outside of the public hearing during the public comment period with staff response and recommendations.

COMMENTS RECEIVED DURING THE PUBLIC COMMENT PERIOD

Brian Hayes, Resident, City of Plymouth

Staff received an email dated May 21, 2013 with the following comment:

Mr. Hayes requested construction of a noise wall on the west side of I-494 from I-394 north to the CSAH 6 exit or to I-694, noting that a potential project is listed in the draft TIP.

Staff response and recommendation: The project, SP# 2785-330, (I-494 unbonded concrete overlay and right side dynamic shoulder from I-394 to I-694/I-94 split) programmed in 2014 includes the construction of noise walls. The exact location of the noise walls will be determined during project development.

Jim Unterseher

Staff received an email dated May 21, 2013 with the following comment:

Mr. Unterseher expressed support for the road project that will eventually widen I-494 from I-394 to the I-694 split.

Staff response and recommendation: Staff assumes Mr. Unterseher is referring to SP# 2785-330, (I-494 unbonded concrete overlay and right side dynamic shoulder from I-394 to I-694/I-94 split) programmed in 2014. Staff thanks Mr. Unterseher for his support.

Amit Mukherjee, Resident, City of Plymouth

Staff received an email dated May 22, 2013 with the following comment:

Mr. Mukherjee expressed support for the construction of a noise barrier in I-494 beyond I-394 in Plymouth.

Staff response and recommendation: The draft 2014-2017 TIP includes SP# 2785-330, (I-494 unbonded concrete overlay and right side dynamic shoulder from I-394 to I-694/I-94 split) programmed in 2014. The project scope includes the construction of noise walls. The exact location of the noise walls will be determined during project development.

Kelli Slavik, Mayor of Plymouth Minnesota

Staff received a letter dated June 11, 2013 and an attachment; a letter dated September 20, 2010 addressed to the Metropolitan Council, with the following comment:

Mayor Slavik stated that SP# 2785-330 (unbonded concrete overlay and right side dynamic shoulder from I-394 to I-694/I-94 split) is very important to the city of Plymouth. The city council was disappointed that the draft 2014-2017 TIP did not a third general purpose lane on I-494 but appreciates that MnDOT is able to provide some capacity improvement given its fiscal constraints.

Staff response and recommendation: MnDOT's State Highway Investment Plan illustrates that the lack of available funding and the high cost of adding mixed use capacity to the region's freeway system limits their ability to address mobility needs. The addition of dynamic shoulder lanes is one tool to address mobility needs as a low cost, high benefit type of project.

Mary Gustafson, Grants Manager, Metro Transit

Staff received an email dated June 24, 2013 and an attached spreadsheet. Ms. Gustafson requested the following changes in program year 2014 in Table A-10; Section 5307 Transit Funding:

- Increase the federal Section 5307 and matching fund amount on TRF-TCMT-14BA (Central Corridor bus facilities and Como Park facility improvements) to adequately fund the project.
- Include TRF-TCMT-14AJ (overhaul base renovation and maintenance shop) and TRF-TCMT-14T (new police facility) with amounts listed on the attached spreadsheet. These projects were not ready for delivery in 2013 as anticipated and need to be carried over to 2014.
- Add a new project, TRF-TCMT-14BC, construction of a light rail platform station at Nicollet Mall, Minneapolis.

Staff response and recommendation: Section 5307 program funds are one of several federal transit program funds that come to the Metropolitan Council as the designated recipient for the region. The adjustment of these funds and the inclusion of a new project represent the normal adjustment to the Program of Projects at the end of a fiscal year. Staff recommends that these changes be included in the final 2014-2017 TIP.

Wayne Sandberg, Washington County Engineer

Staff received a letter dated June 25, 2013 with the following comment:

The proposed TIP is consistent with the current Washington County Comprehensive Plan 2030; however, the county has not been successful in obtaining STP funds for certain regionally

significant projects. Mr. Sandberg cited two TAP projects in Washington County in the draft 2014-2017 TIP.

Staff response and recommendation: The draft 2014-2107 TIP includes projects only within that four-year timeframe. While the current TIP does not include many projects in Washington County, over a longer period of time, the distribution of federal transportation funds has been more geographically equitable. Washington County, along with other local governments, agencies and special interest groups, should continue to advocate for funding of their priority projects..

Mitchell Rasmussen, PE, Scott County Engineer

Staff received a signed letter dated June 27, 2013 with the following comments:

- Scott County requests that the federal Highway Safety Improvement Program funds for project SP# 070-602-020 (CSAH 46 roundabout construction) be advanced from 2015 to 2014 or allow Scott County to Advance Construct the project in 2014, to coincide with a Dakota County project.
- The description of SP# 7005-106 (Table A-8; reconstruct TH 169) should list the eastern project limit as CSAH 21 instead of CSAH 18 because that portion of CSAH 18 was redesignated as CSAH 21 when it was opened to traffic in 2011.

Staff response and recommendation: The region does not have available HSIP funding in program year 2014 but staff recommends that the project be Advance Constructed with local funds in 2014 with the Advance Construction payback in program year 2015. Staff recommends that the description of SP # 7005-106 be changed to reflect the current CSAH designation.

Douglas Fischer, PE, Anoka County Engineer

Staff received a signed letter dated June 28, 2013 with the following summarized comments:

Anoka County lacks major projects in the 2014-2017 TIP and received a disproportionately low share of funding compared to highway miles and daily vehicle miles traveled in the County. The TIP includes only one small NHPP project and does not include any CMAQ or TAP funded projects in Anoka County. As the region implements MAP-21, it should continue to allow fair and robust competition for the regional solicitation funds, and that the distribution of other funds is done fairly and equitably across the region.

Staff response and recommendation: The draft 2014-2107 TIP includes projects only within that four-year timeframe. While the current TIP does not include many projects in Anoka County as Mr. Fischer points out, over a longer period of time, the distribution of federal transportation funds has been more geographically equitable. Anoka County, along with other local governments, agencies and special interest groups, should continue to advocate for funding of their priority projects.

Jenifer Hager, PE, City of Minneapolis

Staff received an email letter dated June 28, 2013 with the following comments:

Minneapolis requested that the "Total" and "Local Share" costs of bridge project SP# 141-454-001 (St. Anthony Pkwy. over BNSF) be increased and bridge project 141-328-004 (10th Ave. over Mississippi River) be reduced.

Staff response and recommendation: The requested cost changes reflect more accurate estimates as these projects proceed through the development process. The cost changes do not affect the projects' score and rank in the regional solicitation process because cost effectiveness is not part of the criteria. Staff recommends that the cost adjustments be included in the final 2014-2017 TIP.

Tom Johnson, Transportation Planning Engineer, Hennepin County

Staff received an email dated June 28, 2013 and an attached table with the following comments:

Hennepin County requests that the "Total" and "Other" or local costs of five projects listed in the table be adjusted to reflect more current cost estimates, and that the description of SP# 027-653-021 be changed to more accurately reflect the project scope as described in the original application.

Staff response and recommendation: The cost changes reflect more accurate estimates as the projects proceed through the development process and they do not appear to affect the project's score and ranking in the regional solicitation process. The requested change in project description does better match the project description found in the original STP application. Staff recommends that the cost adjustments and project description changes be included in the final 2014-2017 TIP.

Scott McBride, Metro District Engineer, Minnesota Dept. of Transportation.

Staff received a letter dated June 28, 2013 requesting that a number of changes be made to state and local projects listed in the Public Hearing copy of the draft 2014-2017 TIP. Mr. McBride stated that this reflects end-of-the-year changes affecting a number of individual projects. Attached to the letter were several tables listing projects to be deferred, projects to be advanced and a table of new projects to be added.

Staff response and recommendation: The changes described in the tables sent with Mr. McBride's letter reflect MnDOT's normal end of fiscal year balancing changes, updated project cost estimates, new project funding commitments and projects shifting among program years within the TIP timeframe. Staff recommends that the changes provided in the attached tables be incorporated into the final 2014-2017 TIP.
